

boundaries of Lot 2, D.P. 33851, and along the production of that last-mentioned boundary to the middle of the Wairoa River in Block XII, Wairoa Survey District; thence northerly down the middle of that river to a point in line with the northern boundary of Allotment 112A, Hunua Parish, and again westerly generally to and along that boundary and the northern boundary of Allotment 112, and its production to the middle of the public road forming the western boundary of that allotment; thence along the middle of that road to and along the middle of the public road forming the western boundary of Allotment 111, the north-western boundaries of Allotments 148, 149, 150, 249, and 151, the western boundary of Allotment 175A, the north-western boundaries of Allotments S. 175 and N.W. 176, the western boundaries of Allotments M. 176 and S.W. 176, and the northern boundary of Allotment 177, all the aforesaid allotments being of Hunua Parish, to the southern boundary of a road reserve shown on S.O. Plan 14113, Sheet 2; thence along a right line across that road reserve to the intersection of the western boundary of that reserve with the right bank of Hay's Creek, and along that right bank to and along the north-eastern boundary of Allotment 168, Hunua Parish, and along that boundary produced to the middle of that portion of a public road forming the south-eastern boundaries of part Allotment N. 171, Hunua Parish, and Lot 2, D.P. 15356; thence along the middle of the said portion of public road and its production to the north-eastern boundary of Lot 3, D.P. 15356, and along that north-eastern boundary to and along the north-eastern boundaries of Allotments 150, 151, 149, 148, and 147, and the north-eastern and north-western boundaries of Allotment 146, to and along the northern end of a closed road, along the north-western side of a public road forming the north-western boundaries of the subdivisions of Allotments 145 and 144, and along the north-western boundary of Allotment 242, all the said allotments being of Opaheke Parish, to and along the northern end of a public road and the north-western boundary of Allotment 116, of Suburban Section 1, Opaheke Parish, and along the production of the last-mentioned boundary to the western side of Dominion Road; thence still westerly, then northerly and again westerly generally along the eastern and northern boundaries of the Papakura Borough as described in *New Zealand Gazette*, 1938, page 470, to the line of mean highwater, spring tides, on the shores of the Pahurehure Inlet of the Manukau Harbour; thence westerly, northerly, and easterly generally along the line of mean high water, spring tides, referred to in the description of the Manukau County, published in *New Zealand Gazette*, 1960, page 1061, to a point in line with the northern side of Portage Road, in Block VI, Otahuhu Survey District, and then easterly along a right line to the point of commencement, and including therein Wiroa, Puketutu, and other adjacent islands within the Manukau Harbour.

SECOND SCHEDULE

MANGERE WARD

ALL that area in the North Auckland Land District bounded by a line commencing at a point in the middle of the North Island Main Trunk Railway in line with the northern side of Portage Road in Block VI, Otahuhu Survey District, and proceeding southerly along the boundary of the City of Manukau hereinbefore described, to a point in the middle of the stream forming the western boundary of Lot 16, D.P. 43797, in Block X, Otahuhu Survey District, in line with the southern boundary of that Lot, and along the production of that southern boundary to the right bank of the said stream; thence generally westerly, northerly, and then easterly along the right bank of that stream and the boundary of the City of Manukau to the point of commencement, and including therein Wiroa, Puketutu, and other adjacent islands within the Manukau Harbour.

THIRD SCHEDULE

OTARA WARD

ALL that area in the North Auckland Land District bounded by a line commencing at the south-western corner of Allotment 94, Pakuranga Parish, in Block VII, Otahuhu Survey District, and proceeding easterly and then southerly along the boundaries of the Pakuranga Ward hereinbefore described to the south-western corner of Allotment 153, Manurewa Parish, in Block XII, Otahuhu Survey District; thence still southerly along the western boundary of Allotment 96 to and along the northern and western boundaries of Allotment 95, Manurewa Parish, to the north-eastern boundary of the part Clendon's Grant shown on D.P. 515; thence westerly generally along the north-eastern boundary and the north-eastern and north-western boundaries of Lot 1, D.P. 24865, to and along the south-eastern and southern sides of Redoubt Road, to and along the generally south-eastern boundary of Lot 1, D.P. 28732, to and along the eastern and south-eastern boundaries of Lot 3, D.P. 41583, the southern boundary of Lot 2, D.P. 41583, the eastern and southern boundaries of Lot 5, D.P. 46004, the southern boundaries of Lots 4, 3, 2, and 1, D.P. 46004, and the north-western boundaries of Lots 2 and 1, D.P. 23951, crossing the intervening public road, to the north-eastern boundary of Lot 5, D.P. 31549; thence along that boundary to and along the north-eastern boundary of Lot 4, D.P. 31549, the north-eastern and north-western boundaries of Lot 3, D.P. 22977, and the generally northern and south-western boundaries of Lot 4, D.P. 31549, to the middle of Orams Road, and

along the middle of that road to the north-eastern side of the Auckland-Hamilton Motorway, in Block XI, Otahuhu Survey District; thence north-westerly generally along the north-eastern side of that motorway, to and easterly along the northern side of Redoubt Road, to and again north-westerly along the north-eastern boundary of the area of 37.3 perches taken for motorway by Proclamation published in *New Zealand Gazette*, 1964, page 1181, and shown on S.O. Plan 44262, along the south-western boundary of Section 8, Block XI, Otahuhu Survey District, along the north-eastern boundary of the area of 3 roads 0.6 perches taken as aforesaid and shown on the said S.O. Plan 44262, and again along the north-eastern side of the Auckland-Hamilton Motorway to a point in line with the southern boundary of Lot 4, D.P. 48617; thence along a right line to the easternmost corner of that Lot 4, and then northerly generally along the boundary of the City of Manukau hereinbefore described, to the point of commencement.

FOURTH SCHEDULE

MANUREWA WARD

ALL that area in the North Auckland Land District bounded by a line commencing at the south-western corner of Lot 16, D.P. 43797, in Block X, Otahuhu Survey District, and proceeding easterly generally along the boundary of the City of Manukau hereinbefore described to and along the boundary of the Otara Ward hereinbefore described to the westernmost corner of Allotment 95, Manurewa Parish, in Block XII, Otahuhu Survey District; thence south-easterly along the north-eastern boundary of the part Clendon's Grant on D.P. 515, and along the production of that boundary to the south-eastern side of the Manurewa-Brookby Road; thence south-westerly along that south-eastern side to and again south-easterly along the north-eastern side of the Alfriston-Ardmore road to and along the north-eastern and south-eastern sides of Mullins Road to and along the north-eastern side of Petersons Road to the northern boundary of Allotment 235, Hunua Parish in Block XI, Wairoa Survey District; thence westerly, north-westerly, and then north-easterly along that northern boundary and the boundary of the City of Manukau hereinbefore described, to and along the left bank of the Waokauri Creek and the left bank of the stream forming part of the western boundary of Lot 27, D.P. 15328, to the point of commencement.

FIFTH SCHEDULE

PAKURANGA WARD

ALL that area in the North Auckland Land District bounded by a line commencing at the south-western corner of Allotment 94, Pakuranga Parish in Block VII, Otahuhu Survey District, and proceeding generally northerly, easterly, and then southerly along the boundary of the City of Manukau hereinbefore described to the south-east corner of Lot 7, D.P. 31974 in Block IV, Wairoa Survey District; thence westerly generally along the southern boundary of that Lot, the southern boundary of Maraetai 1, South A, a right line across North Road to the southernmost corner of Maraetai 4b, and along the southern boundary of the said 4b to and along the western boundaries of Lot 1, D.P. 30672; and Lots 2 and 3, Deeds Plan C. 60, and the northern boundary of Allotment 81 to its north-western corner; thence south-westerly generally along the western boundary of the said Allotment 81, and the western boundary of Allotment 80, both allotments being of Wairoa Parish, to and along the northern boundary of Lot 1, D.P. 39494, the north-eastern boundary of Lot 1, D.P. 39493, crossing an intersecting public road, and along the north-western boundaries of the last-mentioned Lot 1 and of Lot 2, D.P. 39493, to a point in line with the eastern portion of the southern boundary of Lot 1, D.P. 50240; thence to and along the southern boundary of that Lot, to and along the northern boundary of Allotment N.W. 56, Maraetai Parish, to and along the north-eastern and south-eastern boundaries of Lot 16, D.P. 4431, along a right line to the easternmost corner of Lot 18, D.P. 4431, along the south-eastern boundaries of that Lot and of Lots 19 and 20, D.P. 4431, and along the southern boundary of Allotment 178, Pakuranga Parish, to and along the eastern and southern boundaries of Allotment 153, Manurewa Parish, to its south-western corner; thence northerly generally along the western boundary of the last-mentioned allotment, along the southern, western, and northern boundaries of Allotment 138, Pakuranga Parish to and along the western boundary of Allotment 177 and the generally western boundaries of Allotment 178, to and along the south-western boundaries of Lots 8 and 7, D.P. 4431, and along the last-mentioned boundary produced across a public road to and easterly along its northern side to the southern boundary of Allotment 117; thence north-westerly generally along that southern boundary and the eastern boundary of Allotment 274 to and along the north-eastern side of the public road forming the south-western boundaries of Allotments 274, 272, and 267, the said allotments all being of Pakuranga Parish, to and northerly down the middle of the Mangamaungaroa Stream to a point in line with the northern boundary of part Allotment 236, Pakuranga Parish in Block VII, Otahuhu Survey District; thence westerly to and along that boundary, along the northern boundary of Lot 1, D.P. 41857, along a right line across a public road to the north-eastern corner of Lot 1, D.P. 37630, and along the northern boundaries of that Lot 1 and of Lot 1, D.P. 40671, and along that last-mentioned boundary produced to the middle of East Tamaki Road; thence along the middle of that road to and along the middle of
