Lands Set Apart as Provisional State Forest Declared to be Subject to the Land Act 1948

BERNARD FERGUSSON, Governor-General A PRIOCLIAMATION

A PROCLIAMATION PURSUANT to subsection (2) of section 19 of the Forests Act 1949, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Lands and of the Minister of Forests, hereby proclaim and declare that the lands described in the Schedule hereto, being parts of provisional State forest reserves Nos. 1657 and 1690 set apart by Proclamations dated the 11th day of October 1920, and published in *Gazette*, 14 October 1920, Volume III, page 2846, and the 29th day of April 1919, and published in *Gazette*, 8 May 1919, Volume II, page 1284, are required for settlement purposes; and in accordance with the provisions of the said Act such lands shall, from and after the day of the gazetting hereof, cease to be provisional State forest lands and shall become Crown lands available for sale, lease, reservation, or other disposition under the provisions of the Land Act 1948.
