PURSUANT to section 45 of the Burial and Cremation Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Old Kaikora North Cemetery Clearance Order 1966.

(2) This order shall come into force on the day after the date of its publication in the *Gazette*.

2. It is hereby directed that notwithstanding anything in section 41 or section 42 of the Burial and Cremation Act 1964, no further burials shall take place in the Old Kaikora North Cemetery which was closed by an Order in Council dated the 21st day of August 1916* and which is described in the Schedule to that Order in Council.

3. The Patangata County Council is hereby authorised to remove all monuments and tablets erected in that cemetery.

PURSUANT to the Burial and Cremation Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Stoke Cemetery Order 1966.

(2) This order shall come into force on the 1st day of April 1966.

2. The Nelson City Council is hereby appointed to have the control and management of the Stoke Cemetery, being the area described in the Schedule hereto, as from the 31st day of March 1966.

3. The Order in Council dated the 9th day of November 1928* delegating to the Waimea County Council the powers of appointing and removing trustees of the said cemetery is hereby revoked.
