# BERNARD FERGUSSON, Governor-General A PROCLAMATION

A PROCLAMATION PURSUANT to section 2 of the Maori Housing Amendment Act 1938, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby proclaim and declare that the Proclamation published in the *Gazette* on the 27th day of May 1965, at page 855, and registered in the Land Transfer Office at Wellington as number 633450 be and the same is hereby revoked to the extent of the land described in the First Schedule hereto, and in substitution therefor the State housing land within the meaning of the Housing Act 1955, described in the Second Schedule hereto, is hereby set apart for the purposes of the Maori Housing Act 1935.

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto, being an area vested in the North Auckland Education Board as a site for a public school, shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same, at the date hereof.
