At the request of the Minister of Overseas Trade the Tariff and Development Board proposes to inquire into and report on the question of whether the goods listed in paragraph 2 hereunder should be added to Schedule A of the New Zealand - Australia Free Trade Agreement. 2. Each statement will need to be presented under oath at the Public Inquiry by the person tendering it.
7. It should be noted that submissions made to the Department of Industries and Commerce will not be regarded as evidence, unless copies are supplied by applicants to the Board as statements of evidence, and presented under oath as required herein.

Note-The Board has been advised of representations made by interested parties to the Department of Industries and Commerce objecting to the inclusion in Schedule A of the following goods:

Ex. 44.27 Standard lamps, table and other lighting fittings, of wood; articles of furniture, of wood, not falling within Chapter 94; caskets, cigarette boxes, trays and fruit bowls, of wood. Ex. 44.28 Ice cream sticks.

Interdental tooth space cleaners (tooth picks).

One party has objected to the inclusion of the item "other articles of wood" (Ex. 44.28), on the grounds of lack of definition of goods covered by that item.

Another party has supported the inclusion in the Schedule of Beekeepers' woodware, including beehives and frames therefor and components for use in the assembly thereof (Ex. 44.28).
