It will take full account of the advantages and disadvantages to New Zealand industry concerned and to New Zealand as a whole of including the items in Schedule A.

4. For the purpose of taking evidence on this subject the Board will hold a Public Inquiry commencing on Wednesday, 19 July 1967, at 10.30 a.m., in the Board Room, First Floor, N.Z. Law Society Building, 26 Waring Taylor Street, Wellington.

5. Any person who intends to tender evidence will, on notifying the undernamed to that effect, be supplied with a form indicating the nature of the information which should be submitted in support of representations.

6. Twelve copies of a typewritten statement of the evidence to be tendered, compiled in accordance with the form and supported by any additional information, should be lodged with the undernamed not later than Wednesday, 12 July 1967. Each statement will need to be presented under oath at the Public Inquiry by the person tendering it.

7. It should be noted that submissions made to the Department of Industries and Commerce will not be regarded as evidence unless copies are supplied by applicants to the Board as statements of evidence, and presented under oath as required herein.
