Price Order No. 2040 (Nails)

PURSUANT to the Control of Prices Act 1947, I, Geoffrey Harold Datson, pursuant to a delegation from the Secretary of Industries and Commerce, acting under a delegation from the Price Tribunal, hereby make the following price order:

1. This order may be cited as Price Order No. 2040, and shall come into force on the 7th day of July 1967.

(1) Price Order No. 2012* is hereby revoked.

(2) The revocation of the said order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.

APPLICATION OF THIS ORDER

3. This order applies with respect to nails of the kinds and gauges specified in the Schedule hereto.

Where Prices are Expressed Both in Decimal Currency and in Existing Currency

4. (1) Where, in this price order, prices are expressed both in decimal currency and in existing currency, the prices expressed in decimal currency shall be the prices applicable from 10 July 1967, unless, because of difficulties relating to machine conversion, a trader continues to deal during the transitional period exclusively or principally in existing currency, in which case the prices applicable shall be those expressed in existing currency.

(2) In this clause the terms "decimal currency", "existing currency", and "transitional period" shall have the same meaning as in the Decimal

Currency Act 1964.

FIXING MAXIMUM WHOLESALE AND RETAIL PRICES FOR NAILS TO WHICH THIS ORDER APPLIES

Wholesalers' Prices

- 5. The maximum price that may be charged or received by any wholesaler for any nails to which this order applies shall be determined as
- (a) For nails sold by a wholesaler whose place of business is situate in any of the cities of Auckland, Wellington, Christchurch, or Dunedin, the maximum wholesale price shall be the appropriate price fixed in the Schedule hereto:
- (b) For nails sold by any other wholesaler, the maximum wholesale price shall be the appropriate price fixed in the Schedule hereto increased by a proportionate part of any freight charges incurred by the wholesaler in obtaining delivery into his premises.

Retailers' Prices

- 6. The maximum price that may be charged or received by any retailer for any nails to which this order applies shall be determined as follows:
 - (a) For nails sold by a retailer whose place of business is situate in any of the cities of Auckland, Wellington, Christchurch, or Dunedin, the maximum retail price shall be the appropriate price fixed in the Schedule hereto:
 - (b) For nails sold by any other retailer, the maximum retail price shall be the appropriate price fixed in the Schedule hereto increased by a proportionate part of any freight charges paid by the retailer to the wholesaler from whom the nails were purchased or incurred by the retailer in obtaining delivery into his premises.
- 7. If in respect of any lot of nails sold by a retailer the maximum retail price calculated in accordance with the foregoing provisions of this order is not an exact number of pence or halfpence or cents, the maximum price of the lot shall be calculated to the next upward halfpenny, or to the nearest whole cent.

Special Prices Where Extraordinary Charges Incurred

8. Notwithstanding anything in the foregoing provisions of this order and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any wholesaler or retailer, may authorise special maximum prices in respect of any nails to which this order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the wholesaler or retailer. Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of nails, or may relate generally to all nails to which this order applies sold by the wholesaler or retailer while the approval remains in force.

DUTY IMPOSED ON WHOLESALERS

9. Every wholesaler who sells any nails to which this order applies shall specify in the relative invoice with respect to each lot of nails sold the quantity, the gauge, and the length of the nails. SCHEDULE
