Price Order No. 2042 (Eggs—Recovery of Extraordinary Charges)

“Existing Currency” and “Decimal Currency” shall have the same meaning as in the Decimal Currency Act 1964.

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following price order:

PRELIMINARY

1. This order may be cited as Price Order No. 2042 and shall come into force on the 10th day of July 1967.

2. In this order unless the context otherwise requires—

“Cartoned Eggs” means eggs which are packed and supplied by a licensed distributor to a retailer and sold by a retailer to a consumer packed in a divisible “safety” egg carton or in a “unibox” carton.

“Licensed Distributor” means the holder of a distributor’s licence under the Egg Marketing Authority Regulations 1953:

APPLICATION OF THIS ORDER

3. This order applies in respect of all sales in New Zealand whether wholesale or retail, of cartoned eggs of domestic fowls in respect of which special approval has been granted to any retailer or licensed distributor to make an addition to the maximum prices fixed from time to time by price order in respect of extraordinary charges (freight or otherwise) incurred by the retailer or licensed distributor.

CONVERSION OF APPROVED ADDITIONS TO MAXIMUM PRICES FROM THE EXISTING CURRENCY TO DECIMAL CURRENCY

4. Where additions to the maximum prices fixed by price order have been approved in the existing currency in respect of cartoned eggs, such additions are to be converted to decimal currency in accordance with the following table:
