HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL Pursuant to section 8A of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

1. (1) This order may be cited as the Chatham Islands Harbour Control Order 1967.
(2) This order shall come into force on the date of its publication in the *Gazette*.

2. In this order-

"The Act" means the Harbours Act 1950:

"The Council" means the Chatham Islands County Council:

"Minister" means the Minister of Marine; and in-cludes any officer, person, or authority, acting by or under the direction or authority of the Minister.

3. There is hereby granted to the Council for a period of 21 years from the commencement of this order, subject to the provisions of section 8A of the Act and to the conditions specified in the Second Schedule to this order, the control of the waters specified in the First Schedule to this order.

## SCHEDULES

## FIRST SCHEDULE

All the waters contained within the Harbours at Chatham Island and Pitt Island, defined in the Order in Council made on 16 November 1966\*.

# SECOND SCHEDULE

1. Subject to the provisions of section 8A of the Act, the Council for and within the waters described in the First

(a) May by bylaw do anything which a Harbour Board may do by bylaw under section 232 of the Act:
(b) May appoint harbourmasters and/or other officers, and define or limit their powers and duties:
(c) Shall have all the powers, functions, duties, and authorities of a Harbour Board under the Act as if it were constituted a Harbour Board.

2. The said rights, powers, and privileges may be at any time resumed by the Governor-General, without payment of any compensation whatever, on giving to the Council six calendar months' notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at, or posted to the last known address of the Council in New Zealand.
