

## MANUKAU

All that area bounded by a line commencing at a point on the shore of the Hauraki Gulf at the south-eastern corner of Lot 2, D.P. 42589, being a point on the southern boundary of the Electoral District of Pakuranga, hereinbefore described, and proceeding generally south-westerly along the shore of the Hauraki Gulf to and along the left bank of the Maungamaungaroa Creek to a point in line with the southern boundary of part Allotment 235, Pakuranga Parish; thence westerly to and along that boundary, along a right line across Ridge Road, to and along the southern boundary of Allotment 116 of the aforesaid parish and the production of the last-mentioned boundary to the middle of Tamaki Road; thence generally south-westerly along the middle of Tamaki Road, Chapel Road, Ormiston Road, Murphys Road, Redoubt Road, the No. 1 State Highway, Orams Road, and Browns Road, and the production of the middle line of the last-mentioned road to the middle of the Puhinui Creek; thence southerly down the middle of that creek to its mouth and north-westerly to and along the shore of the Manukau Harbour to the middle of the mouth of the Pukaki Creek, being a point on the south-eastern boundary of the Electoral District of Mangere hereinbefore described; thence generally north-easterly along that south-eastern boundary, to and along the south-eastern boundary of the Electoral District of Pakuranga, hereinbefore described, to the point of commencement.

## MANUREWA

All that area bounded by a line commencing at a point on the left bank of the Maungamaungaroa Creek in line with the southern boundary of part Allotment 235, Pakuranga Parish, being a point on the eastern boundary of the Electoral District of Manukau, hereinbefore described, and proceeding due east along a right line to the right bank of the aforesaid creek; thence generally northerly and easterly along that right bank to and along the shore of the Hauraki Gulf, crossing the mouths of the Turanga and Waikopua Creeks, to a point in line with the southern boundary of the part Waiomaru Block shown on D.P. 24411; thence westerly to and along that southern boundary to and southerly along the eastern boundaries of Waihohonu Block to Trig. Station No. 17 (Pukekawa); thence southerly along a right line to Trig. Station No. 1307, and again southerly along a right line to Trig. Station No. 1309, situated in Block VII, Wairoa Survey District; thence south-westerly along a right line to Trig. Station 648, in Block VII, Wairoa Survey District; thence southerly along a right line to the end of Parish Line Road and along the middle of that road to the middle of the Clevedon-Takanini Road; thence generally south-westerly along the middle of the Clevedon-Takanini Road, Mill Road, and Cosgrove Road, to a point in line with the southern boundary of Lot 2, D.P. 55480; thence easterly to and along that boundary, to and southerly along the generally western boundary of Lot 3, D.P. 55480, to the northern side of Old Wairoa Road; thence southerly along a right line crossing Old Wairoa Road to and along the western boundary of Lot 3, D.P. 17674, and its production across Clevedon Road to and along the eastern boundary of Lot 1, D.P. 54654, the eastern end of a public street, the eastern boundaries of Lots 37, 42, 43, 47, 48, 52, 53, 57, 58, and 63, D.P. 54654, the eastern end of another public street, and the eastern boundary of Lot 36, D.P. 54654, to and north-easterly along the south-eastern boundary of Allotment 27, Hunua Parish, to the western side of Dominion Road; thence generally southerly along the western side of that road to and westerly along the northern sides of Hunua and Boundary Roads to the eastern side of Opaheke Road; thence northerly along that eastern side to a point in line with the north-western boundary of Lot 7 of Allotment 15, Opaheke Parish; thence south-westerly to and along that boundary and the northern boundary of Lot 4 of Allotment 15 aforesaid, and the production of the last-mentioned boundary to the western side of the Great South Road; thence southerly along that western side to the south-eastern corner of Lot 11, D.P. 42996; thence westerly along the southern boundary of the said Lot 11 and the southern boundary of Lot 10, D.P. 42996, and northerly, easterly, and again northerly along the western and northern boundaries of Lot 10 aforesaid and the western boundaries of Lots 9, 8, 7, 6, and 5, D.P. 42996, to and along a right line crossing part Allotment E.11, Opaheke Parish, to and along the western boundaries of Lots 4, 3, 2, and 1, D.P. 42996, to the north-western corner of the said Lot 1; thence westerly, northerly, and again westerly along the northern, eastern, and northern boundaries of part Allotment E.11, Opaheke Parish, comprised in certificate of title, Volume 1317, folio 85, to the south-western corner of part Allotment E.11 as shown on S.O. Plan 41427 (taken for Secondary School by *Gazette* 1959, page 1180); thence northerly along the western boundary of the last-mentioned part Allotment E.11 to the southern boundary of Lot 4, D.P. 14721; thence easterly along the southern boundaries of Lots 4, 5, and 6, D.P. 14721, to a point on the production, in a southerly direction, of the western boundary of Lot 11, D.P. 8358; thence northerly to and along that western boundary, crossing Beach Road, to the northernmost corner of that lot; thence easterly along the northern boundaries of Lots 11, 10, 9, 8, and 7, D.P. 8358, to the south-western corner of Lot 12, D.P. 8358; thence northerly along the western boundary of Lot 12 aforesaid, the western end of Clark Road, and the western boundary of Lot 38, D.P. 8358, to and along the southern side of South Street to the shore of the Pahurehure Inlet; thence generally north-westerly along the northern shore of that inlet, crossing the mouth of the Waimahia Creek, and the northern shore of the Manukau Harbour, to the middle of the mouth of the Puhinui Creek, being a point on the boundary of the Electoral District of Manukau, hereinbefore described; thence generally north-easterly along that boundary to the point of commencement; and including all wharves and other extensions seaward; and also including Motukaraka Island.

## FRANKLIN

All that area bounded by a line commencing at a point on the shore of the Hauraki Gulf in line with the southern boundary of the part Waiomaru Block shown on D.P. 24411, being a point on the eastern boundary of the Electoral District of Manurewa, hereinbefore described, and proceeding generally southerly along the shore of the Hauraki Gulf and the Firth of Thames to and along the left bank of the Miranda Stream to a point in line with the western boundary of Lot 2, D.P. 28111; thence generally southerly along a right line across that stream to and along the aforesaid western boundary and the western boundary of Lot 1, D.P. 28111, crossing the intervening Miranda-Waitakaruru Road, along the western boundary of part Waitakaruru 4c 5, the western boundary of Waitakaruru 4c 3, and again along the western boundary of another part of 4c 5 aforesaid, and part Waitakaruru 4c 4, and along the western boundary of Lot 3, D.P. 21822, to its western corner; thence generally southerly along a right line being the production of the last-mentioned boundary across Sections 8 and 10, Block VIII, Wharekawa Survey District, to and along the north-eastern boundary of part Section 1, the north-eastern, eastern, and south-eastern boundaries of Section 2, both sections being of Block VIII aforesaid, and along the northern boundary of part Section 20,
