

Pirongia Parish, the end of a public road, the south-western boundaries of Allotments 352 and 428, Pirongia Parish, and the end of another public road, to Trig. Station Tahuauui; thence generally westerly along the south-eastern, southern, and western boundaries of part Moerangi No. 4 (State Forest, *Gazette* 1948, page 1341), and along the southern boundary of Section 6, Block I, Pirongia Survey District, to its south-western corner, along a right line across Section 9, Block I aforesaid, to an angle opposite in its western boundary and along that western boundary to and along the southern and western boundaries of Section 7, Block I aforesaid, along the southern boundary of Section 4, Block IV, Kawhia North Survey District, and a right line from its south-western corner across Kopunui Road to the nearest road angle on the eastern boundary of Section 18 of the said Block IV; thence generally westerly along the western side of that road, to and along the generally southern boundaries of Section 8, and Lot 2 of Section 7, Block XV, Karioi Survey District, to and along the eastern boundary of Section 1, Block III, Kawhia North Survey District, along the generally southern boundary of Section 2, Block III aforesaid, along the southern and south-western boundaries of part Moerangi 3d 2, along a right line across a public road to and along the south-western boundary of part Moerangi 3d 2 aforesaid, and along the southern boundary of Moerangi 3d 1, and its production to the middle of the Aotea Harbour; thence south-westerly down the middle of that harbour to its mouth; thence generally northerly to and along the sea coast to the middle of the mouth of the Raglan Harbour, being a point on the southern boundary of the Electoral District of Raglan, hereinbefore described; thence generally easterly along that southern boundary to the point of commencement.

#### WAIKATO

All that area bounded by a line commencing at a point in the middle of the Waikato River in the City of Hamilton, in line with the middle line of Boundary Road, being a point on the southern boundary of the Electoral District of Raglan, hereinbefore described and proceeding generally north-easterly along that southern boundary to the northernmost corner of Lot 10, D.P. 5548A, in Block IV, Komakorau Survey District; thence southerly along the western boundaries of Lot 2, D.P. 13235, Lots 6 and 5, D.P. 12470, Lot 1, D.P. 29694, Lot 1, D.P. 29321, Lot 1, D.P. S. 3536, Lot 2, D.P. 20628, part Lot 1, D.P. 3622, and Lot 9, D.P. 6948, along a right line across Piako Road, the Rotorua Branch Railway, and a public road, to and along the western boundaries of Lots 1 and 2, D.P. 8165, Lot 1, D.P. 7723, a right line across the No. 26 State Highway, to and along the western and south-western boundaries of Lot 2 and the south-western boundary of Lot 1, both lots being of D.P. S. 2799, along the southern boundary of part Lot 2, D.P. 7860, to and along a series of right lines passing through parts Tahuroa No. 1 as shown on D.P. 23795, parts Tahuroa No. 1, across Tahuroa Road and through Lot 1, D.P. S. 3993, and Lot 2, D.P. S. 3994, being the generally southern boundaries of Lots 1 and 2, L.T. plan 20705, to the westernmost corner of Lot 5, D.P. 11745; thence generally south-easterly along the western boundaries of the said Lot 5 and Lots 4, 3, 2, and 1, D.P. 11745, and the production of the last-mentioned boundary to the middle of Scotchmans Valley Road, along the middle of that road to a point in line with the south-western boundary of Lot 2, D.P. 15442, along a right line to and along that south-western boundary and along the southern boundaries of Section 7, Block XIV, Maungakawa Survey District, Lots 3 and 4, D.P. S. 2306, and part Teauowaiakato No. 8, to and along the western boundaries of Kiwitahi 2E and 2D, and along the southern boundary of the said 2D and its production to and up the middle of the Topehahae Stream to a point in line with the southern boundary of Kiwitahi 1D 1, along a right line, crossing Waterworks Road, to and along the said boundary, to and southerly along the western boundary of Section 5, Block III, Cambridge Survey District; thence generally south-easterly along the southern boundary of Section 5 aforesaid, and the south-western boundary of Section 4 (Scenic Reserve), Block VIII, Cambridge Survey District, to and southerly along the western boundary of Section 3, Block VIII aforesaid, and the western boundaries of Sections 136, 135, 134, 133, 132, 131, 130, and 129, Matamata Settlement, and along a right line, being the production of the eastern boundary of Section 142, Block XVI, Cambridge Survey District, to and up the middle of the Waikato River to its intersection in Block XII, Maungatautari Survey District, with the right line between Trig. Station No. 807 (Uraura) in Block VII, Ngautuku Survey District, and Trig. Station No. 1427 (Maungatautari), in Block VII, Maungatautari Survey District; thence north-westerly along that right line to the said Trig. Station No. 1427, and along another right line to the easternmost corner of Section 11, Block II, Maungatautari Survey District; thence generally northerly along the north-eastern boundaries of the said Section 11, and Section 9, Block II aforesaid, Lots 2 and 1, D.P. 24663, part of Lot D1 as shown on D.P. 4484, to and along the south-eastern and north-eastern boundaries of Pukekura 18b 2, and the north-eastern boundaries of Pukekura 18b 1A, 18b 1b, and 18b 1c, to and along the south-eastern boundary of Allotment 226, Pukekura Parish, the abutment of a public road, the south-eastern boundary of Allotment 187, the abutment of another public road, the south-eastern boundary of Allotment 186, and the south-eastern boundary of part Allotment 185 as shown on D.P. 5168, the aforesaid allotments all being of Pukekura Parish, the abutment of a public road, the south-eastern boundary of an area of Crown Land, the abutment of a public road, and the south-eastern boundaries of Allotments 184, 234, and part 227, Pukekura Parish, Lot 1, D.P. 19889, another part of Allotment 227 aforesaid, crossing the intersecting public road, and along a right line being the last-mentioned boundary produced to the middle of the Waikato River; thence north-westerly down the middle of that river to a point in line with the western boundary of Lot A, D.P. 2894, in Block IX, Cambridge Survey District; thence southerly along a right line to and along that western boundary, the western boundaries of Lot C, D.P. 2894, Lot D1, D.P. 3600, and Lot 1, D.P. S. 1769, a right line across a public road to and along the western boundary of part Allotment 126, Pukekura Parish on D.P. 2572, a right line across Lamb Street, to and along the western boundary of parts Allotments 151 and 171, Pukekura Parish, comprised in C.T. 579/244, a right line across part Allotment 171, aforesaid, comprised in C.T. 579/239, to and along that portion of the generally southern boundary of the land in that title running south-westerly and shown thereon as a distance of 580 links, to an angle; thence generally westerly along another right line across part Allotment 171, aforesaid, comprised in C.T. 878/5, to and along the northern boundaries of Lots 2 and 1, D.P. 33439, to and northerly along the eastern side of the Cambridge - Roto-o-rangi Main Road to a point in line with the southern boundary of Lot C, D.P. 3295; thence westerly along a right line across that road to and along that southern boundary, the southern boundaries of Lot B, D.P. 3295, part Lot B1, D.P. 15521, another part of Lot B1, D.P. 3295, and Lot B2, D.P. 3295, and Lots A3, A2, A1, and A, D.P. 3117, to the eastern boundary of Lot 2, D.P. 4699; thence generally northerly along that eastern boundary, the eastern boundaries of part Allotment 26, Pukekura Parish, Lot 1, D.P. S. 278, along a right line across Lamb Street to and along the eastern boundaries of Lot 1, D.P. S. 1517, part Lot 1, and Lot 2, D.P. 3517, the eastern end of a public road, and the eastern boundaries of Allotments 21 and 21A, Pukekura Parish, along a right line across the Te Awamutu - Cambridge Road to and along the eastern boundary of Allotment 20b, Pukekura Parish, and the production of the last-mentioned boundary to the middle of the Waikato River; thence generally north-westerly down the middle of that river to the point of commencement.
