

corner of Small Grazing Run 50; thence westerly along a right line to that corner and generally westerly along the south-eastern and southern boundaries of Small Grazing Run 49, and the south-eastern boundaries of Sections 1 and 2, Block IV, Wainuioru Survey District, and along the production of the last-mentioned boundary to the middle of the Kuamahanga Stream; thence generally north-westerly down the middle of that stream to its confluence with the middle of the Wainuioru River; thence generally southerly down the middle of that river to a point in line with the south-eastern boundary of Section 79, Tupurupuru Block; thence north-westerly to and along that boundary and the south-eastern boundary of Section 76, Tupurupuru Block, and north-westerly along the north-eastern boundaries of Sections 76, 77, 62, and 54, Tupurupuru Block, to the north-western boundary of Section 1, Block XIV, Otahoua Survey District; thence generally north-easterly along that north-western boundary, the western boundaries of Lots 3 and 2, D.P. 1569, the north-western boundaries of part Lot 1, D.P. 1569, and the land shown on D.P. 7679, the western boundaries of Sections 3 and 2, Block XI, Otahoua Survey District, the south-western and north-western boundaries of the land shown on Land Transfer Plan A/2492, to and down the middle of the Pohatu Stream to its confluence with the Tauweru River; thence generally northerly up the middle of that river to a point in line with the western boundary of the part of Taumataraiia Block shown on Land Transfer Plan A/2001; thence northerly along a right line to and along the said western boundary and its production to the northern side of the Masterton-Tauweru Road; thence westerly along that northern roadside, to and north-easterly along the south-eastern boundaries of Lots 18, 12, 11, 10, 7, 6, 4, and 2, D.P. 16228, to the north-eastern corner of the last-mentioned lot; thence westerly along the northern boundary of Lot 2 aforesaid, to a point in line with the south-eastern boundary of Lot 17, D.P. 15594; thence north-easterly to and along the south-eastern boundary of Lot 17 aforesaid, and its production to and along the south-eastern boundaries of Lots 16, 15, 14, 13, 12, 11, 10, and 9, D.P. 15594, and along their production to and along the south-eastern boundaries of Lots 8, 7, 6, 5, 4, 3, 2, and 1, D.P. 15594, and along the production of the last-mentioned boundary to the north-eastern boundary of Lot 1, D.P. 15154; thence north-westerly along that north-eastern boundary to and north-easterly along the south-eastern side of Gordon Street to a point in line with the south-western boundary of Lot 2, D.P. 11197; thence north-westerly to and along that boundary, to and along the south-eastern boundary of Lot 1, D.P. 5623, to its intersection with the northern boundary of Section 73, Masterton Small Farm Settlement; thence westerly along the northern boundaries of Section 73 aforesaid, and Section 72, Masterton Small Farm Settlement, to and northerly along the eastern side of Manuka Street to a point in line with the northern side of Fifth Street; thence westerly to and along that northern side to and southerly along the eastern side of the No. 2 State Highway, to a point in line with the northern boundary of Lot 2, D.P. 16830; thence westerly to and along that northern boundary and southerly along the western boundary of that lot to the northern boundary of Section 63, Masterton Small Farm Settlement; thence generally westerly along that northern boundary to and along the south-eastern side of the Wellington-Napier Railway, to and up the right bank of the Waipoua River to a point in line with the north-western boundary of Section 31, Masterton Small Farm Settlement; thence south-westerly along a right line in the direction of the intersection of the middle line of the road passing through Lot 1, D.P. 4017, with the middle line of Ngaumutawa Road, to the south-western side of Akura Road; thence north-westerly along that south-western roadside to and south-westerly along the north-western side of Ngaumutawa Road to the south-western boundary of Lot 1, D.P. 4017; thence generally north-westerly along the generally south-western boundaries of Lot 1, D.P. 4017, and the southern and western boundaries of Lot 1, D.P. 19644, to the northernmost corner of Lot 2, D.P. 16822; thence westerly along a right line to peg 1 on S.O. Plan 21461 on the north-western side of Kibblewhite Street; thence south-westerly along that north-western roadside and its production to the south-western side of Upper Plain Road; thence south-easterly along that south-western roadside to and south-westerly along the south-eastern boundary of Section 42, Masterton Small Farm Settlement, to a point 215 links from the south-western side of Upper Plain Road; thence south-easterly along a right line parallel to, and distant 215 links in a south-westerly direction from, the south-western side of Upper Plain Road, to the north-western boundary of Lot 2, D.P. 18820; thence south-westerly along the north-western boundaries of Lots 2 and 1, D.P. 18820, and south-easterly along the south-western boundary of Lot 1 aforesaid, and the production of the last-mentioned boundary to the south-eastern side of Chamberlain Street; thence north-easterly along that side to the south-western boundary of Lot 1, D.P. 365; thence generally south-easterly along the south-western and south-eastern boundaries of Lot 1, D.P. 365, the south-western boundaries of Lots 1, 2, and 3, D.P. 16695, along a right line to and along the south-western boundary of Lot 4, D.P. 16695, the south-western and south-eastern boundaries of Lot 5, D.P. 16695, to and along a right line parallel to, and distant 215 links in a south-westerly direction from, the south-western side of Upper Plain Road, to the north-western side of Railway Road; thence south-westerly along the north-western side of Railway Road, crossing the intervening West Bush Road, to the north-eastern boundary of part Lot 1, D.P. 3011; thence westerly along the north-eastern and northern boundaries of part Lot 1 aforesaid, and the production of the last-mentioned boundary across Boundary Road and the land as shown on Land Transfer Plan B.170 to the eastern boundary of Section 135, Masterton Small Farm Settlement; thence southerly along that eastern boundary, along a right line across Upper Manaia Road, to and southerly along the eastern boundary of Section 137, Masterton Small Farm Settlement, and along the production of the last-mentioned boundary to the middle of the Waingawa River; thence generally north-westerly up the middle of that river and its northern branch (Arete Stream) to its source; thence due west along a right line to the summit of the Tararua Range; thence north-easterly along that summit to Trig. Station Mount Dundas and along a right line in the direction of Trig. Station Arawaru in Block VIII, Arawaru Survey District, to its intersection with another right line bearing 295° 30' magnetic, as described in the Schedule of the Eketahuna County Act 1898, from a point in the middle of the Makakahi River in line with the western boundary of Section 21, Block XIV, Tararua Survey District, being a point on the south-eastern boundary of the Electoral District of Manawatu, hereinbefore described; thence north-easterly along that south-eastern boundary and the south-eastern boundary of the Electoral District of Rangitikei, hereinbefore described, to and easterly along the southern boundary of the Electoral District of Hawke's Bay, hereinbefore described, to the point of commencement.

WAIRARAPA

All that area bounded by a line commencing at Mount Hector on the summit of the Tararua Range and proceeding north-easterly along that summit to a point due west of the source of the northern branch (Arete Stream) of the Waingawa River, being a point on the south-western boundary of the Electoral District of Pahiatua, hereinbefore described; thence south-easterly along that south-western boundary to the middle of the mouth of the Kaiwhata River on the sea coast; thence generally south-westerly and north-westerly along the sea coast to a point in line with the north-eastern boundary of Orongorongo A 1 Block; thence north-westerly to and along that boundary to the summit of the Rimutaka Range; thence north-easterly along the summit of the Rimutaka and Tararua Ranges to the point of commencement.
