

OTAKI

All that area bounded by a line commencing at a point in the middle of the mouth of the Manawatu River, being a point on the south-western boundary of the Electoral District of Manawatu, hereinbefore described, and proceeding south-easterly along that south-western boundary to and south-westerly along the north-western boundaries of the Electoral Districts of Pahiatua and Wairarapa, hereinbefore described, to Mount Hector on the summit of the Tararua Range; thence westerly along a right line to the easternmost corner of Lot 10, D.P. 618, situated in Block III, Akatarawa Survey District; thence westerly along the north-eastern boundary of that lot, across a public road, to and along the north-eastern and north-western boundaries of Lot 8, D.P. 619, to the north-eastern boundary of Ngarara West C 18, Section 1; thence southerly along the south-eastern boundaries of Ngarara West C 18, Section 1, and Ngarara West C 22, to and along the eastern boundary of Section 1, Block III, Akatarawa Survey District, to the generally north-eastern side of a public road; thence generally westerly along that roadside to a point in line with the southern boundary of Section 1, Block III aforesaid; thence westerly to and along that southern boundary, and generally northerly along the western boundary of that section to and along the generally northern boundary of Section 415, Hutt District, and the production of the last-mentioned boundary to the generally western side of the Akatarawa Road; thence generally southerly along that roadside to and westerly along the northern boundary of Section 414, Hutt District, and along the production of that boundary to the generally northern side of a public road; thence generally south-westerly along the northern and north-western sides of that public road to the southern boundary of Section 13, Block I, Akatarawa Survey District; thence westerly along that southern boundary to and south-westerly along the north-western boundary of part Section 15, Block I aforesaid, the north-western boundary of the land shown on D.P. 10581, the north-western boundaries of Sections 18, 1, 2, 3, 4, and 5, Block V, Akatarawa Survey District, Sections 13 and 12, Block IX, Akatarawa Survey District, to and along the eastern boundary of Section 1, Block IX aforesaid, to a point in line with the northern boundary of the land shown on D.P. 4705; thence to and along that northern boundary to and generally southerly along the eastern boundary of that land to the northern boundary of Section 12, Block XIII, Akatarawa Survey District; thence westerly along that northern boundary, the northern boundaries of Sections 8 and 7, Block XIII aforesaid, to and southerly along the western boundary of Section 7 aforesaid, to the south-eastern boundary of Section 5, Block XIII aforesaid; thence along the southern boundaries of that section and a right line across the Whakatiki River and Birch Spur Road, to and along the western boundary of Section 31, Block XIII aforesaid, to the south-western corner of that section; thence along a right line to the north-eastern corner of Section 9, Block XIII aforesaid, and south-easterly along the eastern boundaries of Sections 9 and 23, Block XIII, Akatarawa Survey District, to the north-eastern corner of Section 26, Block XIII aforesaid; thence westerly along a right line to Trig. Station Moonshine, and southerly along a right line to Trig. Station Nabhra, and along a further right line to Trig. Station Cecil; thence southerly along a right line to a point in the middle of the Hutt River in line with the southern boundary of Section 269, Hutt District, in Block IV, Belmont Survey District; thence westerly to and along that southern boundary, the northern boundary of part Lot 2, D.P. 7415, and the northern boundary of the land shown on D.P. 3448, to the northernmost corner of that land; thence generally southerly along the generally western boundaries of that land to its westernmost corner, and westerly along the northern boundary of Section 196A, Hutt District, to and north-westerly along the north-eastern boundary of Section 197, Hutt District, to the easternmost corner of Section 265, Hutt District; thence south-westerly along the south-eastern boundaries of Sections 265, 264, 263, 262, 261, and 255, Hutt District, the northern boundary of part Lot 2, Deeds Plan 578, along that boundary and the northern boundary of part Lot 1, Deeds Plan 578, to and along the northern and western boundaries of Sections 430, 431, and 335, and the northern boundaries of Sections 333, 328, and 331, to the north-western corner of the aforesaid Section 331, all the aforesaid sections being of Hutt District; thence north-easterly along the north-western boundaries of Sections 339 and 340, the north-western and north-eastern boundaries of Section 343, and the eastern boundaries of Sections 344 and 348, all the aforesaid sections being of Hutt District, to the southern boundary of Lot 12, D.P. 3138; thence generally north-westerly along the southern boundaries of Lots 12, 11, and 10, D.P. 3138, the southern and western boundaries of Lot 9, the southern boundary of Lot 3, the southern and western boundaries of Lot 1, all the aforesaid lots being of D.P. 3138, to and along the south-eastern boundary of Section 99, Porirua District, to the easternmost corner of that section; thence easterly along the southern boundaries of Sections 97, 96, 95, and 94, Porirua District, to and northerly along the eastern boundary of Section 94 aforesaid, and its production to the shore of the Porirua Harbour; thence northerly along a right line across the Porirua Harbour to a point on its northern shore in line with the south-western boundary of Section 84, Porirua District; thence north-westerly to and along that boundary and its production to the eastern side of the No. 1 State Highway; thence northerly along that eastern side to a point in line with the northern boundary of Lot 2, D.P. 20043; thence westerly to and along that northern boundary, to and along the northern boundaries on Hongoeka 1A 1 and 1A 2, a right line across Pukerua Road to and along the southern boundary of Haukopua West Block to the sea coast; thence generally northerly along the sea coast to the point of commencement; and including Kapiti Island and other adjacent islands.

PORIRUA

All that area bounded by a line commencing at a point on the sea coast at the north-western corner of Hongoeka 6A in Block V, Paekakariki Survey District, being a point on the boundary of the Electoral District of Otaki, hereinbefore described, and proceeding generally southerly along that boundary to the north-western corner of Section 331, Hutt District, in Block II, Belmont Survey District; thence generally south-westerly along the south-eastern boundaries of Sections 30, 29, 28, 27, 26, 25, 24, 22, 21, 20, and 16, Horokiwi Road District, to the production of a right line between Trig. Station No. 3, situated in Block VII, Belmont Survey District, and Trig. Station Magee, situated in Block VIII, Belmont Survey District; thence westerly to and along that right line and its production to the middle of the No. 1 State Highway; thence northerly along that highway to a point in line with the southern boundary of Section 39, Porirua District; thence westerly along that southern boundary to the north-eastern corner of Lot 2, D.P. 20867, crossing the intervening North Island Main Trunk Railway; thence south-easterly along the north-eastern boundaries of Lots 2 and 1, D.P. 20867, to and north-westerly along the south-western boundaries of the said Lot 1 to a point in line with the south-eastern boundary of Lot 5, D.P. 16632; thence south-westerly to and along that south-eastern boundary and westerly along the southern boundaries of Lot 5 aforesaid and Lot 1, D.P. 16632, and the southern boundary of the part Section 34, Porirua District, comprised in certificate of title, Volume 821, folio 90, to the south-western corner of that part; thence generally northerly along the western boundary of part Section 34 aforesaid,
