north-easterly to and along that eastern boundary, the southern and eastern boundaries of Section 15, Block X aforesaid, the eastern boundaries of Sections 14, 13, 12, part 11, of Section 15, Block A aroresate, the eastern boundaries of Sections 14, 15, 12, part 11, 3, 2, and 21, all of the said Block X, crossing an intervening public road, to and along the southern boundaries of Sections 55 and 64, along a right line across a public road to and along the southern boundaries of Sections 72, 31, 3, and 4, and the western, southern, and eastern boundaries of Section 8, all the aforesaid sections being of Block VI, Hukerenui Survey District, and the production of the last-mentioned boundary to the northern side of the Awanui-Bluff State Highway No. 1; thence south-easterly along the northern side of the Awanui-Bluff State Highway No. 1; thence south-easterly along the northern side of that highway, to and along the eastern side of Tapuhi Road, crossing the railway at Hukerenui Railway Station, to the middle of the Waipuakakhau Stream; thence generally south-easterly along the middle of that stream to the westernmost corner of Section 18, Block X, Hukerenui Survey District; thence south-easterly along the North Auckland Railway to its intersection with the No. 1 State Highway at the southern boundary of Section 2, Block XI, Hukerenui Survey District; thence due south to the middle of that highway and generally south-easterly along the middle of that highway to a point in line with the south-eastern boundary of Section S.E. 38, Hikurangi Parish; thence generally north-easterly to and along the southern and eastern boundaries of thence generally north-easterly to and along the southern and eastern boundaries of Section S.E. 38, aforesaid, the south-eastern boundary of Section 10, Block XVI, Hukerethence generally north-easterly to and along the southern and eastern boundaries of Section S.E. 38, aforesaid, the south-eastern boundary of Section 10, Block XVI, Hukerenui Survey District, and the production of the last-mentioned boundary to the eastern side of a public road forming the generally eastern boundary of the aforesaid Section 10; thence generally north-easterly along the eastern side of the said road to and along the northern boundary of Section 3, Block XVI, aforesaid, crossing the intervening Otonga-Marua Road, and that boundary produced to and generally southerly up the middle of the Te Waiongatahuna Stream to a point in line with the southern boundary of Section 13, Block VII, Opuawhanga Survey District; thence north-easterly along a right line to and along that southern boundary and the southern boundaries of Sections 35 and 46, Block VII, aforesaid, to and along the southern and eastern boundaries of Section 47, and along a right line crossing Section 42 to the south-western corner of Section 44; thence still north-easterly generally along the generally southern boundary of Section 44, all the aforesaid sections being of the said Block VII, and the last-mentioned boundary produced to and along the middle of Jubilee Road and along the middle of a public road forming the southern boundaries of Section 12, Block VII, Sections 37, 35, 28, and 26, Block VIII, and parts Sections 8 and 7, Block V, all the aforesaid sections being of Opuawhanga Survey District, to and down the middle of a stream which crosses the aforesaid road, to and down the middle of the Whannanki Inlet, to the mouth of that inlet on the sea coast; thence north-westerly, westerly, and south-easterly generally along the sea coast, crossing the mouths of all harbours and inlets, to the point of commencement; and including the Cavalli Islands, Motuopao, Moturoa, Murimotu, and Stephenson's Islands, the Poor Knights Islands and other adjacent islands.

All that area bounded by the line commencing at a point in the middle of the mouth of the Whangarei Harbour and proceeding due west to Marsden Point; thence generally north-westerly along the southern shore of the Whangarei Harbour, crossing the mouths north-westerly along the southern shore of the Whangarei Harbour, crossing the mouths of all inlets, to a point in line with the north-eastern boundary of Te Rewarewa B2; thence generally north-westerly to and along the generally northern boundaries of Te Rewarewa B2 and B lb, southerly along the western boundary to Te Rewarewa B 1a 3a, along a right line across a public road to the north-western corner of Te Rewarewa B 1a 2, and along the western boundaries of that B la 2 and Te Rewarewa B la 1, and the western and south-western boundaries of Te Rewarewa A, to and up the middle of Te Waiiti Stream, to and southerly along the western side of State Highway No. 1, to and along the south-eastern boundary of Lot 1, D.P. 33086, to a point in line with the south-western boundary of Lot 2, D.P. 40082; thence north-westerly to and along that boundary, south-westerly along the north-western boundary of the said Lot 1, D.P. 33086, and again north-westerly along the north-eastern boundaries of Section 22, Block XVI, Purua Survey District, and Ruarangi Block, to and south-westerly along the north-western boundary of the said Ruarangi Block to its westernmost corner; thence south-westerly along a right line to the northernmost corner of Otara Al Block the north-western boundary of the said Ruarangi Block to its westernmost corner; thence south-westerly along a right line to the northernmost corner of Otara Al Block, in Block XVI, Purua Survey District; thence along the generally western boundary of the aforesaid Al Block and that boundary produced to and up the middle of the Otaika Stream, to and down the middle of the Otakaranga Stream, to and westerly generally along the northern side of a public road forming the northern boundaries of Allotments 86, 85, 84, and 83, Maungatapere Parish, to the southernmost corner of Allotment 75, Maungatapere Parish aforesaid; thence southerly along a right line across the said road, to and along the north-western boundary of the said Allotment 83, and the north-western boundary of part Allotment 104, to the south-eastern corner of Allotment 183 in Block XV, Purua Survey District, all the aforesaid allotments being of Maungatapere Parish; thence south-western boundary of pand along the north-western boundary of XV, Purua Survey District, all the aforesaid allotments being of Maungatapere Parish; thence south-westerly along a right line to and along the north-western boundary of Allotment 107 of the said parish, to its westernmost corner; thence along another right line to and along the north-western boundary of Allotment 136, Maungatapere Parish, to and north-westerly along the northern end of a public road, along the north-eastern boundaries of Allotments N. 120 and M. 113, and the north-eastern and northern boundaries of Allotment N. 113, all the aforesaid allotments being of Maungatapere Parish, and the last-mentioned boundary produced to the middle of the Waionepu River; thence down the middle of that river and down the middle of the Waiotama River to the boundary of the Electoral District of Hobson, hereinbefore described; thence generally north-westerly and easterly along that boundary to the middle of the mouth of the Whananaki Inlet; thence generally southerly to and along the sea coast, crossing the mouths of all harbours and inlets, to the point of commencement; and including the Hen and Chicken Islands, Fanal, Mokohinau, and Pataua Islands, and other adjacent islands.

All that area bounded by a line commencing at Marsden Point, being a point on the boundary of the Electoral District of Marsden, hereinbefore described, and proceeding generally southerly along the sea coast, crossing the mouths of all harbours and inlets, to a point on the southern boundary of Allotment 37, Okura Parish, in Block XVI, Waiwera Survey District; thence westerly along the southern boundaries of Allotment 37 and part Allotment 36, Okura Parish aforesaid, crossing Long Bay Drive and Beach Road, and the production of the last-mentioned boundary to the middle of Glenvan Road; thence generally south-westerly along the middle of Glenvan Road, East Coast Road, and Albany Browns Bay Road to the middle of the No. 1 State Highway; thence generally north-westerly along the middle of that highway to and generally southwesterly along the middle of the No. 18 State Highway to its junction with the middle of Wake Road; thence due west along a right line to the middle of the Rangitopuni Stream; thence generally south-westerly along the middle of that stream to the middle of the No. 18 State Highway aforesaid; thence generally southerly along the middle of that highway to a point in line with the southern boundary of Allotment 449, Paremoremo
