across Section 88, Waimea South District, to the westernmost corner of Section 29, Wai-iti Hills District; thence south-easterly along the western and southern boundaries of Section 29 aforesaid, to and southerly along the western boundaries of Sections 28 of Section 29 aforesaid, to and southerly along the western boundaries of Sections 28 and 20, Wai-iti Hills District, to the southernmost corner of the last-mentioned section; thence south-westerly along a right line to Trig. Station F.F. in Block IV, Gordon Survey District; thence south-westerly along a right line to Trig. Station A.A. in Block VII, Gordon Survey District; thence south-westerly along a right line to Trig. Station B in Block VII aforesaid; thence south-westerly along a further right line in the direction of Trig. Station Reays Hill in Block X, Gordon Survey District, to the intersection of that right line with the eastern side of the old Belgrove-Tophouse Road; thence generally southerly along that eastern side to the north-eastern boundary of Section 10, Square 45; thence south-easterly along that boundary to and easterly along the northern boundary of Section 8, Square 45, to and southerly along the eastern boundaries of Section 8 aforesaid, and Section 9, Square 45, to the eastern boundary of Block X. northern boundary of Section 8, Square 45, to and southerly along the eastern boundaries of Section 8 aforesaid, and Section 9, Square 45, to the eastern boundary of Block X, Gordon Survey District; thence southerly along the eastern boundaries of Blocks X and XIV, Gordon Survey District, to and easterly along the northern boundaries of Blocks III and IV, Motupiko Survey District, to the intersection of the last-mentioned boundary with a right line between Wards Pass and Trig. Station Top 2; thence southeasterly along the north-eastern boundary of Section 3, Square 34, and its production across the No. 63 State Highway, to and south-westerly along the southern side of that highway to the westernmost corner of Section 6, Square 34; thence north-easterly and south-easterly along the north-western and south-western boundaries of the said Section south-easterly along the north-western and south-western boundaries of the said Section 6 to the easternmost corner of Section 11, Block XIV, Motupiko Survey District; thence south-westerly along the south-eastern boundary of the said Section 11 to the summit of the St. Arnaud Range; thence generally south-westerly along that summit and the summits of the Spencer Mountains and the Southern Alps to Mount Aspiring; thence westerly along a right line between Mount Aspiring and the middle of the mouth of the Awarua River in Big Bay to the middle of the Pyke River; thence generally southerly along the middle of the Pyke and Hollyford Rivers to a point due east of Mount Tutoko; thence due west to Mount Tutoko and north-westerly along a right line to Yates Point on the sea coast; thence generally north-easterly along the sea coast, crossing the mouths of all harbours and inlets, to the point of commencement.

Station Grants Lookout, Mount Robinson, and Trig. Stations M, N, P, Ref, and Onahau, to the intersection of that ridge with a right line between the north-western corner of Section 21, Pelorus Sound Registration District, and the south-eastern corner of Lot 4, D.P. 1760; thence southerly
