All that area bounded by a line commencing at a point on the sea coast in line with the south-western boundary of Rural Section 36498, in Block II, Weld Survey District, being a point on the southern boundary of the Electoral District of Marlborough, hereinbefore described, and proceeding generally south-westerly along the sea coast, crossing the mouths of all harbours and inlets, to a point in line with the middle line of Beach Road, in Block VIII, Christchurch Survey District; thence westerly to and along the middle of that road to a point in line with the western boundary of Lot 1 , D.P. 16752; thence northerly to and along that western boundary and the western boundary of part Reserve 1579 to the middle of Florance Avenue; thence westerly along the middle of Florance Avenue to and northerly along the middle of Bower Avenue to a point in line with the southern boundary of Rural Section 13981; thence westerly to and along that southern boundary to the eastern boundary of Lot 1, D.P. 20980; thence southerly along the eastern boundaries of Lots 1, 5, 4, and 3, D.P. 20980, to the south-eastern corner of the last-mentioned lot; thence westerly along the southern boundaries of Lots 3 and 2, D.P. 20980, along a right line to the north-eastern corner of Lot 32, D.P. 8314, and again along the southern boundary of Lot 2, D.P. 20980, to the south-western corner of the last-mentioned lot; thence generally south-westerly along the eastern boundary of Lot 1, D.P. 11317 to the northern side of Silvia Street, along that northern side, to and along the western side of Badger Street, to and along the southern, eastern, and again southern boundaries of Lot 3, D.P. 11317, to and along the southern boundary of Reserve 4175 to its south-western corner; thence southerly along the western boundary of Reserve 4079 and its production to the middle line of Beach Road; thence westerly along the middle of Beach Road, southerly along the middle of Frosts Road, westerly along the middle of Travis Road, to and southerly along the middle of Burwood Road to its junction with the middle of Lake Terrace Road; thence north-westerly along the middle of Lake Terrace Road, Briggs Road,
