

## WIGRAM

All that area bounded by a line commencing at the intersection of the middle lines of Lincoln Road and Moule Street, being the southernmost point on the boundary of the Electoral District of Riccarton, hereinbefore described, and proceeding south-westerly along the middle of Lincoln Road and Halswell Road, to and south-easterly along the middle of Hendersons Road, to and north-easterly along the middle of Sparks Road to a point in line with the north-eastern boundary of Lot 1, D.P. 20481; thence southerly to and along that north-eastern boundary, the north-eastern boundaries of Lot 2, D.P. 20481, part Lot 15, D.P. 3217, and Lot 22, D.P. 3217, and along the production of the last-mentioned boundary to the middle of Cashmere Road; thence generally south-westerly along the middle of that road, to and generally southerly along the middle of Paterson Avenue and its production to the south-western side of Kennedys Bush Road; thence north-westerly along that south-western roadside to and along the north-eastern boundary of Lot 1, D.P. 14689, to the northernmost corner of that lot; thence generally south-westerly along the north-western boundaries of Lots 1 and 2, D.P. 14689, Lot 4, D.P. 14253, part Lot 5, D.P. 5068, and Lot 4, D.P. 5068, to the westernmost corner of the last-mentioned lot; thence south-easterly along the south-western boundary of Lot 4 aforesaid, to its south-western corner and along a right line across the Old Taitapu Road, to and along the north-eastern boundary of Rural Section 1329/1330 measuring 91 links and its production to the middle of the Halswell River; thence generally southerly down the middle of that river to a point in line with the middle line of Rhodes Road; thence south-easterly to and along the middle of Rhodes Road to a point in line with the south-eastern boundary of Lot 2, D.P. 1085; thence north-easterly to and along that south-eastern boundary and the south-eastern boundary of part Rural Section 3695x to its easternmost corner; thence generally easterly, (passing through Rural Sections 38521, 38522, and 38523,) along the northern boundary of former Rural Section 17739x, along the western and northern boundaries of former Rural Section 34552, to a point in line with the northern boundary of former part Rural Section 34551, along a right line to and along that northern boundary to the western side of Summit Road; thence easterly along a right line across Summit Road to and along the northern boundary of part Rural Section 34551 to its easternmost corner on the summit of the Port Hills; thence generally southerly along that summit to and along the eastern boundaries of Lots 1 and 2, D.P. 10264, in Blocks VII and XI, Halswell Survey District, the eastern and south-eastern boundaries of Rural Section 1863, and the south-eastern and south-western boundaries of Rural Section 1901, to a point in line with the middle line of Ahuriri Bush Road South; thence generally south-westerly to and along the middle of that road and Ahuriri and Little River Road to a point in line with the former south-eastern boundary of Rural Section 1069; thence south-westerly to and along that boundary (through Rural Section 37634) and its production to the middle of the Halswell River; thence generally south-easterly down the middle of that river to its mouth at Lake Ellesmere; thence generally north-westerly to and along the generally northern shore of Lake Ellesmere to the middle of the mouth of the Selwyn River; thence generally north-westerly up the middle of that river to the middle of the South Island Main Trunk Railway; thence north-easterly along the middle of that railway to the middle of Burnham Road; thence generally northerly along the middle of that road, Aylesbury Road, Sandy Knolls Road, Halkett Road, and Intake Road, to a point in line with the northern boundary of Rural Section 12536; thence westerly to and along that boundary to the eastern boundary of Rural Section 9616; thence northerly along that eastern boundary and its production to the middle of the Waimakariri River, being a point on the southern boundary of the Electoral District of Rangiora, hereinbefore described; thence generally easterly along that southern boundary to and generally south-easterly along the western boundary of the Electoral District of Papanui, hereinbefore described, and the western and south-western boundaries of the Electoral District of Riccarton, hereinbefore described, to the point of commencement.

## SYDENHAM

All that area bounded by a line commencing at a point in the middle of the Heathcote River in line with the middle line of Waltham Road, being a point on the generally southern boundary of the Electoral District of Christchurch Central, hereinbefore described, and proceeding generally south-westerly up the middle of the Heathcote River and the middle of the Cashmere Stream to a point in line with the south-western boundary of part Lot 3, D.P. 12061; thence north-westerly to and along that south-western boundary and the south-western boundary of Lot 1, D.P. 17148, and along the production of the last-mentioned boundary to the middle of Cashmere Road, being a point on the generally eastern boundary of the Electoral District of Wigram, hereinbefore described; thence generally northerly along that generally eastern boundary, to and generally easterly along the generally southern boundaries of the Electoral Districts of Riccarton and Christchurch Central, hereinbefore described, to the point of commencement.

## LYTTELTON

All that area bounded by a line commencing at a point on the sea coast in line with the north-eastern boundary of the land contained in C.T.430/216, being the land described in Section 108 of the Reserves and Other Lands Disposal and Public Bodies Empowering Act 1919, being a point on the southern boundary of the Electoral District of Avon, hereinbefore described, and proceeding generally south-easterly, southerly, and westerly along the sea coast, crossing the mouths of all harbours and inlets, to the middle of the former outlet of Lake Ellesmere (east of Maori Reserve 878); thence north-easterly along a right line to the middle of the mouth of the Halswell River on the northern shore of Lake Ellesmere, being a point on the eastern boundary of the Electoral District of Wigram, hereinbefore described; thence generally northerly along that eastern boundary, to and generally easterly along the generally southern boundaries of the Electoral Districts of Sydenham, Christchurch Central, and Avon, hereinbefore described, to the point of commencement; and including the Chatham Islands.
