

of the Lyttelton-Invercargill-Bluff Railway; thence generally westerly along the middle of that railway to a point in line with the middle line of Hanover Street; thence generally north-westerly to and along the middle of Hanover Street, Filleul Street, Cargill Street, Stuart Street, Kaikorai Valley Road, and Frasers Road to a point in line with the north-western boundary of Section 9, Block X, Dunedin and East Taieri Survey District; thence westerly along a right line to a point in the middle of Dalziel Road in line with the north-eastern boundary of Section 1, Block X aforesaid; thence generally northerly along the middle of that road to a point in line with the south-eastern boundary of Section 50, Wakari Survey District; thence north-easterly to and along that boundary to and north-westerly along the north-eastern boundary of that section to the south-eastern boundary of Section 34, Wakari Survey District; thence north-easterly along the south-eastern boundaries of Sections 34 and 32, Wakari Survey District, to and north-westerly along the north-eastern boundary of Section 32 aforesaid and its production to the middle of Taieri Road; thence south-easterly along the middle of that road to a point in line with the south-eastern boundary of Section 31, Wakari Survey District; thence north-easterly to and along that south-eastern boundary to the north-eastern corner of that section, being a point on the generally south-eastern boundary of the Electoral District of Otago Central, hereinbefore described; thence generally north-easterly to and along that generally south-eastern boundary to and generally easterly along the generally southern boundary of the Electoral District of Oamaru, hereinbefore described, to the point of commencement; and including all wharves and other extensions seawards.

DUNEDIN CENTRAL

All that area bounded by a line commencing at a point on the north-western shore of the Otago Harbour in the middle of the mouth of the Water of Leith, being a point on the southern boundary of the Electoral District of Dunedin North, hereinbefore described, and proceeding south-westerly along the north-western shore of the Otago Harbour to a point in line with the middle line of Mason Street; thence south-westerly along a right line to a point on the shore of the Otago Harbour in line with the middle line of Orari Street; thence south-westerly to and along the middle of Orari Street to and north-westerly along the middle of Andersons Bay Road to the middle of the Lyttelton-Invercargill-Bluff Railway; thence generally south-westerly along the middle of that railway to a point in line with the middle line of Surrey Street; thence south-easterly along the production of the middle line of Surrey Street to the middle of South Road; thence generally south-westerly along the middle of South Road, David Street, Forbury Road, Easther Crescent, and Rainton Road, to and along the middle of an accessway between Rainton Road and Murray Street, to and along the middle of Murray Street, Corstorphine Road, and Stevenson Road, to a point in line with the north-western boundary of the land shown on D.P. 6828; thence south-westerly to and along that north-western boundary and the north-western boundary of the land shown on D.P. 6805, to and south-easterly along the south-western boundary of the land shown on D.P. 6805 aforesaid, and along the production of the last-mentioned boundary to the middle of Middleton Road; thence westerly along the middle of that road to a point in line with the north-eastern boundary of part Section 70, Ocean Beach Survey District, comprised in C.T. 275/29; thence south-easterly to and along that north-eastern boundary and its production to the middle of Hillhead Road; thence north-easterly along the middle of that road to a point in line with the north-eastern boundary of Section 47, Ocean Beach Survey District; thence south-easterly to and along that north-eastern boundary, south-westerly along the south-eastern boundaries of Sections 47 and 48, Ocean Beach Survey District, to and generally southerly along the north-eastern and south-eastern boundaries of part Section 1, Block XIII, Dunedin, and East Taieri Survey District, comprised in C.T. 275/29 and C.T. 218/179, and the production of the last-mentioned boundary to the sea coast; thence generally westerly along the sea coast to the middle of the mouth of the Kaikorai Stream, being a point on the south-eastern boundary of the Electoral District of Otago Central, hereinbefore described; thence generally north-easterly along that boundary to and generally south-easterly along the southern boundary of the Electoral District of Dunedin North, hereinbefore described, to the point of commencement; and including all wharves and other extensions seaward.

ST. KILDA

All that area bounded by a line commencing at a point on the shore of the Otago Harbour in line with the middle line of Orari Street, being a point on the generally eastern boundary of the Electoral District of Dunedin Central, hereinbefore described, and proceeding south-easterly along the seaward side of the retaining wall at the south-western end of the Otago Harbour to the north-western side of Portobello Road; thence north-easterly along the north-western side of the causeway road across Andersons Bay to and generally north-easterly, southerly, and south-westerly along the south-eastern shore of the Otago Harbour and the sea coast, crossing the mouths of all inlets, to a point in line with the south-eastern boundary of part Section 1, Block XIII, Dunedin and East Taieri Survey District, comprised in C.T. 275/29, being a point on the south-eastern boundary of the Electoral District of Dunedin Central, hereinbefore described; thence generally north-easterly along that south-eastern boundary to the point of commencement; and including all wharves and other extensions seaward, and also including Pudding Island and other adjacent islands on the sea coast.

CLUTHA

All that area bounded by a line commencing at a point on the sea coast in the middle of the mouth of the Taieri River, being a point on the south-western boundary of the Electoral District of Otago Central, hereinbefore described, and proceeding generally south-westerly along the sea coast, crossing the mouths of all harbours and inlets, to the middle of the mouth of Longbeach Creek in Block XIII, Tautuku Survey District; thence generally north-westerly up the middle of Longbeach Creek to the middle of the No. 92 State Highway; thence westerly along the middle of that highway, to and northerly along the eastern boundaries of Blocks XV and XIV, Waikawa Survey District, to and westerly along the northern boundary of Block XIV aforesaid to the eastern boundary of Section 5, Block XIV, Mokoreta Survey District; thence northerly along that eastern boundary and its production to the middle of a public road forming the northern boundary of Sections 5, 3, and 2, Block XIV aforesaid; thence north-westerly along the middle of that road to a point due south of Trig. Station EE in Block XIV, Mokoreta Survey District; thence due north along a right line to Trig. Station EE aforesaid and generally northerly along the summit of the watershed, passing through Table Ridge, Mount Alfred and Trig. Station G, to Trig. Station H (Chimney) in Block III, Mokoreta Survey District; thence north-easterly along a right line to peg XIII on the south-western boundary of Lot 2, D.P. 3410; thence generally north-westerly and north-easterly along the south-western and north-western boundaries of the said Lot 2 to its northernmost corner; thence north-westerly along the southern boundary of Section 5, Block VII, Slopdown Survey District, and its production to the eastern boundary of Run 251; thence generally northerly along the generally eastern
