All that area bounded by a line commencing at a point on the left bank of the Waihopai River in the middle of Stead Street and proceeding south-westerly along the middle of that street to and north-westerly along the middle of Curran Road and Otatara Road to a point due west of the south-western corner of the castermmost part of Section 15, Block XV, Invercargill Hundred; thence due east to that corner and north-easterly along the south-eastern boundaries of part Section 15, and of Section 21, Block XV aforesaid, to the westernmost corner of Lot 9, D.P. 822; thence south-easterly and north-easterly along the south-eastern and south-eastern boundaries of the said Lot 9, and north-easterly along the south-eastern and south-eastern corner of the said Lot 9, and north-easterly along the south-eastern boundarys of Lots 3, 7, 6, 5, 4, and part Lots 3, 2, and 1, D.P. 822, to the south-eastern corner of the last-mentioned lot; thence northerly along the eastern boundary of the said part Lot 1, and the eastern boundary of part Section 13, Block XV aforesaid, to the south-eastern corner of Lot 1, D.P. 2533; thence southerly, easterly, and again southerly along the eastern boundaries of Section 158, Block XV aforesaid, to the south-eastern corner of that section; thence north-easterly along a right line to and along the south-eastern boundaries of Section 32 and part Section 33, Block XV aforesaid, to and northerly along the eastern boundaries of part Section 33, Block XV aforesaid, to and northerly along the middle of that road and southerly along the middle of horth Road to the middle of that road and southerly along the middle of North Road to the middle of the Waihopai River; thence generally easterly up the middle of the Waihopai River; thence generally easterly up the middle of the Waihopai River; thence generally easterly up the middle of the waihopai River; thence south-easterly along that infibit line to the morth-eastern boundary of part Section 3, Block II, In
