

BIRKENHEAD

All that area bounded by a line commencing at a point on the right bank of Hellyer's Creek due south of the southernmost corner of Lot 26, D.P. 2093, in Block VII, Waitemata Survey District, being a point on the boundary of the Electoral District of Waitemata, hereinbefore described, and proceeding generally north-easterly and south-westerly along the right bank and the south-eastern bank of that creek to and generally south-easterly and easterly along the north-eastern and northern shores of the Waitemata Harbour to the south-eastern boundary of Lot 1, D.P. 31225, being Allotments 68 and 69, Takapuna Parish; thence south-westerly to the southern corner of the said Lot 1; thence north-westerly along the south-western boundary of that Lot 1, along a right line across Northcote Road, to and along the south-western boundaries of Allotments 92 and 103, and Lot 33, D.P. 8521, being part Allotment 104, Takapuna Parish, along the south-western end of Porana Road and the south-western boundaries of Lots 18 and 17, D.P. 8521 aforesaid, being parts of the said Allotment 104, to Archers Road; thence north-easterly generally along the south-eastern side of that road to the northern corner of Lot 9, D.P. 8521 aforesaid, and along a right line across Archers Road aforesaid to the southern corner of Lot 17, D.P. 9343, being part Allotment 190 of the said Parish; thence generally north-easterly along the north-western side of Archers Road to the north-eastern corner of Lot 2, D.P. 21594, being part Allotment 190 aforesaid, and along a right line across Forrest Hill Road, to and along the north-western boundary of Lot 137, D.P. 8886, the north-western end of Corunna Road and the north-western boundaries of Lots 16, 15, 4, and 1, D.P. 36360, the aforesaid lots all being parts of Allotment 190 aforesaid, to and along the north-western end of Nile Road, to and generally northerly along the generally eastern boundary of Lot 12, D.P. 12173 to the boundary of the Electoral District of Waitemata, hereinbefore described; thence generally northerly, north-westerly, and south-westerly along that boundary to the point of commencement; and including all wharves and other extensions seawards.

NORTH SHORE

All that area bounded by a line commencing at a point on the shore of the Hauraki Gulf in line with the middle line of Rahopara Street and proceeding south-easterly, westerly, and northerly generally along that shore and the shore of the Waitemata Harbour to the south-eastern boundary of Lot 1, D.P. 31225, being Allotments 68 and 69, Takapuna Parish, being a point on the eastern boundary of the Electoral District of Birkenhead, hereinbefore described; thence generally northerly and easterly along the eastern and southern boundaries of the Electoral Districts of Birkenhead and Waitemata to the point of commencement; and including all wharves and other extensions seaward.

HENDERSON

All that area bounded by a line commencing at a point in the middle of the Huru-huru Creek in line with the middle line of Rathgar Road, being a point on the boundary of the Electoral District of Waitemata, hereinbefore described, and proceeding generally northerly along the middle of Huru-huru Creek and Henderson Creek, to its mouth on Waitemata Harbour; thence southerly to and along the western shore of that harbour and the left bank of the Whau River, crossing the mouth of the Wairau Creek, to a point in line with the northern boundary of Lot 3, D.P. 11169, being part Allotment 89 Waikomiti Parish, in Block III, Titirangi Survey District; thence westerly to and along that northern boundary to the eastern boundary of Allotment 204, Waikomiti Parish, and southerly along the eastern boundary of Allotment 204, aforesaid, and Allotments 203, 202, 201, 200, 199, and 198, Waikomiti Parish, to and easterly along the northern boundary of Allotment 196, Waikomiti Parish, and the production of the last-mentioned boundary to the middle of Lynwood Road; thence southerly along the middle of that road and westerly along the middle of Great North Road to a point in line with the eastern boundary of Allotment 162, Waikomiti Parish; thence southerly to and along the eastern boundary of Allotment 162, aforesaid, to the southernmost corner of that allotment, crossing the intervening Newmarket-Opua Railway; thence westerly along the southern boundary of Allotment 162, aforesaid, crossing the intervening Newmarket-Opua Railway, and the southern boundary of Lot 19, D.P. 21448, to the south-eastern side of Waikumete West Coast Road; thence generally northerly along that south-eastern side to and along the south-western side of the Great North Road, to a point in line with the middle line of Archibald Road; thence northerly to and along the middle of Archibald Road to a point in line with the south-western boundary of Allotment 221, Waikomiti Parish; thence north-westerly to and along the south-western boundaries of Allotments 221, 233, 232, and 230, all of Waikomiti Parish, and the production of the last-mentioned boundary to the middle of Sabulite Road; thence southerly along the middle of Sabulite and Eden View Roads to the middle of the Newmarket-Opua Railway; thence north-westerly along the middle of that railway to a point in line with the south-eastern boundary of Section 98, Waari Hamlet; thence generally westerly to and along the south-eastern boundary of Section 98 aforesaid, and its production to the middle of a stream; thence north-westerly along the middle of that stream to a point in line with the western boundary of Lot 27, D.P. 17808; thence southerly to and along the western boundary of Lot 27 aforesaid, and the western boundaries of Lots 26, 25, 24, 23, 22, 21, 20, 19, and 18, D.P. 17808 aforesaid, the western boundary of Lot 2, D.P. 37752, and the western boundary of Lot 17, D.P. 17808, and the production of the last-mentioned boundary to the middle of Waikumete West Coast Road; thence easterly along the middle of that road to a point in line with the eastern boundary of Lot 4, Deeds Plan 269; thence generally southerly to and along that boundary, and the northern and eastern boundaries of Allotment 114, Waikomiti Parish, and the production of the last-mentioned boundary to the middle of View Road; thence westerly along the middle of that road to a point in line with the eastern boundary of Lot 4 of Allotment 15, Waikomiti Parish; thence southerly to and along the eastern boundaries of Lots 4, 3, 2, and 1, of Allotment 15 aforesaid, and the eastern boundary of Allotment 112 of the said parish to and south-easterly along the generally western boundaries of Lot 1, D.P. 28402, to the northern boundary of Lot 1, D.P. 7428; thence westerly, southerly, and easterly along the northern, western, and southern boundaries of Lot 1, D.P. 7428; to the northern side of the Waitakere Scenic Drive; thence due south to the middle of that scenic drive and generally westerly along its middle line to a point in line with the western boundary of Allotment 26 of the said parish; thence southerly to and along that western boundary, to and along the western boundaries of Lots 28, 29, and 30, D.P. 39183, being parts Allotment 26 aforesaid, to and westerly along the northern boundary of Lot 1, D.P. 35700, being part Allotment 29, along a right line to and northerly along the generally eastern boundary of Lot 4, D.P. 32219, being parts Allotments 83 and 27 of the aforesaid parish, and the production of the last-mentioned boundary to the middle of the Waitakere Scenic Drive; thence generally southerly along the middle of that scenic drive, Shaw Road, Exhibition Drive, and Huia Road, to the middle of the Nihotupu Stream; thence southerly down the middle of that stream to its mouth on the shore of the Manukau Harbour; thence generally south-westerly and northerly along that shore and the sea coast to the middle of the Anawhata Stream, being a point on the boundary of the Electoral District of Waitemata, hereinbefore described; thence generally north-easterly along that boundary to the point of commencement.
