

## NEW LYNN

All that area bounded by a line commencing at a point on the left bank of the Whau River on the northern boundary of Lot 3, D.P. 11169, being part Allotment 89, Waikōmīti Parish, in Block III, Titirangi Survey District, being a point on the boundary of the Electoral District of Henderson, hereinbefore described, and proceeding generally south-easterly along the left bank of the Whau River, crossing the mouth of the Rewarewa Creek, to the middle of Wolverton Street; thence generally easterly and southerly along the middle of that street, Miranda Street, Blockhouse Bay Road, Margate Road, Whitney Street, Donovan Street, and Lewis Street, and the production of the middle line of the last-mentioned street to the shore of the Manukau Harbour; thence generally south-westerly along that shore to the middle of the Nihotupu Stream, being a point on the boundary of the Electoral District of Henderson, hereinbefore described; thence generally north-easterly along that boundary to the point of commencement, and including all wharves and other extensions seaward.

## GREY LYNN

All that area bounded by a line commencing at a point on the shore of the Waitemata Harbour in line with the middle line of Alford Street and proceeding generally north-easterly along that shore to a point in line with the middle of New Street; thence generally southerly to and along the middle of New Street, College Hill, Ponsonby Road, Richmond Road, Leighton Street, Williamson Avenue, Grosvenor Street, the Great North Road, and Commercial Road to the southern side of Dale End; thence westerly along that southern side to and along the southern boundaries of Allotments 18, 19, and 20, Section 7, Suburbs of Auckland, crossing the intervening Mountain View Road and Wexford Street, to the south-western corner of the aforesaid Allotment 20; thence southerly along the western boundaries of Lots 13, 12, 11, 10, 9, 8, 7, 6, 5, 4, and 3, Block VI, D.P. 8784, to the eastern side of Derwent Street; thence southerly along the eastern side of that street to and easterly along the northern side of Bannerman Road to a point in line with the north-western boundary of Lot 44, D.P. 4838; thence southerly along a right line, crossing Bannerman Road, to and along that north-western boundary, and the western boundaries of Lots 23, 24, and part 35, Block III, D.P. 339, crossing the intervening Springfield Road, and the production of the last-mentioned boundary to the middle of Western Springs Road; thence westerly along the middle of Western Springs Road to and southerly along the middle of Asquith Avenue to a point in line with the southern boundary of Lot 1, D.P. 42036; thence westerly to and along the said southern boundary and the southern boundaries of part Allotment 173 comprised in C.T. 532/250, and Allotment 175, and southerly along the eastern boundary of part Allotment 174 comprised in C.T. 532/265, the said allotments all being of Section 10, Suburbs of Auckland and being parts of Chamberlain Park, to the northern end of Burnside Avenue; thence westerly along that northern end and the northern boundary of part Allotment 36, Titirangi Parish, to the middle of the Meola Stream; thence generally south-westerly down the middle of that stream to a point in line with the middle line of Parkdale Road; thence southerly to and along the middle of Parkdale Road, westerly along the middle of Fontenoy Street, northerly along the middle of Rawalpindi Street, westerly along the middle of Segar Avenue, and southerly along the middle of Carrington Road to a point in line with the southern boundary of Allotment 32, Titirangi Parish; thence westerly to and along that southern boundary and its production to the middle of Oakley Creek; thence northerly down the middle of that creek to a point in line with the northern boundary of Allotment 104, Titirangi Parish; thence westerly to and along that northern boundary and its production to the middle of the Great North Road; thence northerly and north-westerly along the middle of the Great North Road and Alford Street and the production of the middle line of the last-mentioned street to the point of commencement; and including all wharves and other extensions seaward.

## MOUNT ALBERT

All that area bounded by a line commencing at a point in the middle of Commercial Road on the southern side of Dale End and proceeding generally southerly along the southern side of Dale End to and along the middle of Central Road to the southern side of New North Road; thence generally southerly along that southern side to and along a footbridge across the Newmarket-Opua Railway and due south to the middle of Sandringham Road; thence southerly along the middle of Sandringham Road to the middle of Mount Albert Road; thence generally north-westerly along the middle of Mount Albert Road and Owairaka Avenue to a point in line with the eastern boundary of Section 51, Titirangi Parish; thence southerly and westerly to and along the eastern and southern boundaries of Section 51 aforesaid, and the production of the last-mentioned boundary to the middle of Richardson Road; thence south-easterly along that road to the middle of Oakley Creek; thence generally westerly along the middle of that creek to the middle of Bollard Avenue; thence generally southerly along the middle of Bollard Avenue, New Windsor Road, and Whitney Street to the intersection of the middle lines of Whitney Street and Margate Road, being a point on the eastern boundary of the Electoral District of New Lynn, hereinbefore described; thence generally westerly along that boundary to the right bank of the Whau River in the middle of Wolverton Street; thence generally north-westerly along that right bank to and generally south-easterly and northerly along the shore of the Waitemata Harbour to a point in line with the middle line of Alford Street being a point on the southern boundary of the Electoral District of Grey Lynn, hereinbefore described; thence generally easterly along that southern boundary to the point of commencement; and including Pollen and Traherne Islands.

## ROSKILL

All that area bounded by a line commencing at the intersection of the middle lines of Sandringham and Mount Albert Roads being a point on the boundary of the Electoral District of Mount Albert, hereinbefore described, and proceeding south-easterly along the middle of Mount Albert Road to a point in line with the western boundary of Lot 5 of a subdivision of Allotments 3 and 5 of Section 13, Suburbs of Auckland; thence southerly generally to and along the western and southern boundaries of the said Lot 5, the southern boundary of Lot 9 of a subdivision of Allotment 3 of Section 13, Suburbs of Auckland, to the north-western corner of Lot 10, of a subdivision of Allotments 3 and 4 of Section 13 aforesaid; thence generally southerly along the western boundary of the said Lot 10 and its production to and along the northern and western boundaries of Lot 13 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, the western boundaries of Lots 14 and 15 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, and Lots 19 and 20 of a subdivision of Allotment 4 of Section 13, Suburbs
