

Ladies Mile to a point on the right line between the south-western corner of Allotment 25, Section 12, Suburbs of Auckland, and a point on the line between Standard Survey Blocks M. 753 (Great South Road) and M. 752 (Wairakei Street) and distant 113 links from the first-mentioned Standard Block; thence south-westerly along that right line to the aforesaid point 113 links from Standard Survey Block M. 753; thence north-westerly along a right line to and along the north-eastern side of the Great South Road to a point in line with the middle line of Campbell Road; thence south-westerly to and along the middle of Campbell Road to a point in line with the north-eastern side of Tiwai Road; thence north-westerly to and along that north-eastern side and its production to the south-western corner of Lot 6, D.P. 21889; thence south-westerly along the south-eastern boundaries of Lots 6, 5, 4, 3, 2, and 1, D.P. 21889, the south-eastern boundaries of Lots, 28, 27, 26, 25, 24, 23, 22, 21, 20, 19, and 18, D.P. 18933, the south-eastern boundaries of Lots, 20, 19, 18, 17, 16, 15, 14, 13, and 12, D.P. 21888, the south-eastern boundary of part Lot 1, D.P. 4094, and the production of the last-mentioned boundary to the middle of Manukau Road; thence southerly along the middle of Manukau Road to and westerly along the middle of Mount Albert Road to the middle of Buckland Road, being a point on the eastern boundary of the Electoral District of Eden, hereinbefore described; thence generally northerly along that eastern boundary, to and generally easterly and northerly along the southern and eastern boundaries of the Electoral District of Auckland Central, hereinbefore described, to the point of commencement.

ONEHUNGA

All that area bounded by a line commencing at a point in the middle of Gollan Road on its northern end, being a point on the boundary of the Electoral District of Remuera, hereinbefore described, and proceeding generally southerly along the middle of Gollan Road, Harding Avenue, Marua Road, Burt Road, the Eilerslie-Panmure Highway, Ferndale Road, Panorama Road, Penrose Road, the Mount Wellington Highway, and Waipuna Road, to the western side of the Auckland-Westfield Railway; thence generally southerly along that side to the northern shore of the Manukau Harbour; thence generally westerly along that northern shore to a point in line with the middle line of Goodall Street, being a point on the eastern boundary of the Electoral District of Roskill hereinbefore described; thence generally north-easterly along that eastern boundary, to and generally north-easterly along the south-eastern boundary of the Electoral District of Remuera, hereinbefore described, to the point of commencement; and including all wharves and other extensions seaward.

TAMAKI

All that area bounded by a line commencing at a point on the northern side of Tamaki Drive due north of the western side of Ngapipi Road at Hobson Point, being a point on the boundary of the Electoral District of Remuera, hereinbefore described, and proceeding generally easterly along the shore of the Waitemata Harbour and generally southerly up the left bank of the Tamaki River to the middle of the mouth of the Omaru Creek; thence generally westerly up the middle of that creek to the middle of Maybury Street; thence generally south-westerly along the middle of Maybury Street, Line Road, Point England Road, and Merton Road to the middle of the Auckland-Westfield Railway, being a point on the north-eastern boundary of the Electoral District of Remuera, hereinbefore described; thence generally north-westerly along that north-eastern boundary to the point of commencement; and including all wharves and other extensions seaward.

PAKURANGA

All that area bounded by a line commencing at a point on the left bank of the Tamaki River in the middle of the mouth of the Omaru Creek, being a point on the southern boundary of the Electoral District of Tamaki, hereinbefore described, and proceeding southerly along the left bank of the Tamaki River to a point in line with the middle line of Point England Road; thence easterly along the production of the middle line of Point England Road to the right bank of the Tamaki River; thence generally northerly along that bank to and generally south-easterly along the shore of the Hauraki Gulf to the south-eastern corner of Lot 2, D.P. 42589; thence westerly along the southern boundary of that lot to a point in line with the south-eastern boundary of Lot 1, D.P. 39879; thence generally south-westerly along a right line to and along that south-eastern boundary, and crossing the intervening Lot 1, D.P. 43578, to and along the south-eastern boundary of Lot 74, D.P. 16751, and the north-eastern, south-eastern, and south-western boundaries of Lot 75, D.P. 16751, to and along the south-eastern side of Pah Road to a point in line with its southern side as formed by part of the north-eastern boundary of Lot 2, D.P. 17330; thence generally north-westerly along a right line to and along that southern side, to and along the north-eastern and north-western boundaries of Lot 2, D.P. 17330, the north-eastern boundary of part Lot 1, D.P. 17330, and along the south-western boundary of Lot 2, D.P. 46951 to peg VIII A; thence north-westerly along a right line to the northernmost corner of Lot 13, D.P. 17330, to and south-westerly along the northern and north-western boundaries of Lot 13 aforesaid, the north-western boundaries of Lots 7 and 10, D.P. 17330, to and north-westerly along the north-eastern side of Sandspit Road to a point in line with the north-western side of a public road forming the north-western boundary of Allotment 71, Pakuranga Parish; thence westerly along a right line across Sandspit Road to the easternmost corner of part Allotment 1, Section 8, Small Farms Near Howick, on D.P. 21150; thence generally westerly along the north-eastern side of the aforesaid public road, to and along the northern and north-western boundaries of Allotment 13, the north-western boundary of Allotment 12, the north-eastern boundary of Allotment 6, all the aforesaid allotments being of Section 8 aforesaid, and along a right line across the Howick-Manurewa Main Road, to the easternmost corner of Lot 1, D.P. 40828; thence generally south-westerly along the north-western side of the aforesaid road, to and north-westerly along the north-eastern boundaries of Allotments 10 and 6, Pakuranga Parish, to the northernmost corner of the last-mentioned allotment; thence westerly along a right line bearing $279^{\circ} 03' 30''$ for a distance of 353.78 links, crossing Botany Road; thence north-westerly generally along a series of right lines parallel to, and 250 links distant from, the western side of Botany Road aforesaid, to the intersection of the most northern of those lines with a right line parallel to, and 275 links distant in a south-easterly direction from, the south-eastern side of Bradbury Road; thence south-westerly along a right line parallel to, and 275 links distant from, the last-mentioned roadside, to and along the south-eastern boundaries of Lots 1, 2, 3, 4, 5, 6, and 7, D.P. 34192, along a right line across part Lot 1, D.P. 1841, to and along the south-eastern boundaries of Lots 8, 9, and 10, D.P. 34192, along a right line across Lot 1, D.P. 31709, to and along the south-eastern boundaries of Lots 1, 2, and 3, D.P. 40867, along a right line to and along the south-eastern boundaries of Lots 5, 6, 7, and 8, D.P. 40867, along a right line to and along the south-eastern boundaries of Lots 10 and 11, D.P. 40867, to and southerly along the eastern boundaries of Lots 1, 2, 3, 4, and 5, D.P. 45626, the eastern and south-eastern boundaries of Lot 6, D.P. 45626, and the south-eastern boundary of Lot 7, D.P. 45626, to and south-westerly along the south-eastern boundaries of Lots 17, 18, and 19, D.P. 40867, along a right line to and along the south-eastern boundaries of Lots 21, 22, 23, and 24, D.P. 40867, along a right line to and along
