

*Land Taken for Electric Works in Block I, Teviotdale Survey District, Waipawa County, and Revoking Previous Proclamation*

A PROCLAMATION

PURSUANT to section 32 of the Public Works Act 1928 and section 35 of the Finance Act (No. 2) 1945, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 30th day of May 1967, and published in *Gazette*, 22 June 1967, No. 39, page 1063, proclaiming and declaring land to be taken for electric works and vested in the North Canterbury Electric Power Board, and hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for electric works and shall vest in the North Canterbury Electric Power Board as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 16th day of October 1967.
