COROMANDEL COUNTY COUNCIL

RESOLUTION MAKING SPECIAL RATE

Bridge Construction Loan 1966—\$30,000

PURSUANT to the Local Authorities Loans Act 1956, the Coromandel County Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of \$30,000 to be known as the Bridge Construction Loan 1966, authorised to be raised by the Coromandel County Council under the said Act for the purpose of meeting the Council's share of the cost of replacing bridges in the County, the said Council hereby makes a special rate of decimal one six six cents in the dollar upon the rateable value of all rateable property in the Ridings of Colville, Waiau, Mercury Bay, and Whenuakite; and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of April in each and every year during the currency of the loan, being a period of 35 years, or until the loan is fully paid off."
