

Survey District; thence westerly along the northern boundary of that section to its north-western corner; thence southerly generally along the western boundaries of Sections 6, 5, 4, and 3, Block VI, Waro Survey District, to and easterly along the southern boundaries of Section 3, Block VI, and Section 1, Block VII, Waro Survey District, to the north-western side of Kotare Road; thence generally easterly along the northern side of Kotare Road to the middle of a stream near the southern boundary of Section 2, Block VII, Waro Survey District; thence easterly down the middle of that stream to its confluence with the Waitaanga Stream; thence southerly generally down the middle of that stream and the Tangarakau Stream to the Confiscation Line; thence south-westerly along that line to the northern boundary of Block XVI, Waro Survey District; thence westerly along the northern boundaries of Blocks XVI and XV, Waro Survey District, to the western side of Mount Damper Road North; thence generally southerly and westerly along the western and northern sides of that road to the northern boundary of Section 8, Block XIV, Waro Survey District; thence westerly along that boundary to the Okau Road; thence along a right line to the northern boundary of Section 5, Block XIV, Waro Survey District; thence westerly along the northern boundary of that section and the northern boundaries of Sections 10 and 9, Block XIII, Waro Survey District, to and south-westerly along the north-western boundary of the said Section 9, to Rerekapa Road; thence along a right line to the eastern boundary of Section 3, Block XIII, Waro Survey District; thence generally southerly along that boundary to and along a right line across Crown land intersecting the said Section 3 to and again southerly along the eastern boundary of that section and Section 11 of the said Block XIII; thence generally southerly along the western boundary of Section 4, Block I, Pouatu Survey District, to the northern side of the Moki Road; thence along a right line to the northern boundary of Section 8, Block I, Pouatu Survey District; thence generally southerly along the eastern boundary of the said Section 8 to the southernmost corner of the said Section 8, thence along a right line across Section 8, Block V, Pouatu Survey District, and Makino North Road to the eastern boundary of Section 7 of the said Block V; thence generally southerly and westerly along the eastern and southern boundaries of Sections 7, 6, and 5 of the said Block V; thence generally westerly along the southern boundary of Section 4, Block VIII, Upper Waitara Survey District, to the eastern boundary of Section 1, Block XII, of the said Survey District; thence southerly along the eastern boundary of the said Section 1 and its production to the middle of the Mangaowata Stream; thence westerly generally down the middle of that stream to a point in line with the eastern boundary of Section 3, Block XII, Upper Waitara Survey District; thence southerly generally to and along the eastern boundary of the said Section 3 to the northern side of the Mangare Road; thence easterly along the northern side of Mangare Road to a point in line with the eastern boundary of Section 8, Block XII, Upper Waitara Survey District; thence along a right line across Mangare Road to the eastern boundary of the said Section 8; thence southerly along the eastern boundaries of the said Section 8 and Section 2, Block XVI, Upper Waitara Survey District; thence generally westerly and northerly along the southern and western boundaries of the said Section 2 and Section 9, Block XI, Upper Waitara Survey District, and the production of the last-mentioned boundary to the middle of the Waitara River; thence south-westerly generally down the middle of the Waitara River to a point in line with the western boundary of Section 1, Block X, Upper Waitara Survey District; thence northerly to and along the western boundary of that section, to and westerly along the northern boundary of Section 18, Block XIV, Upper Waitara Survey District, to the north-eastern side of the Mangapito Road; thence south-easterly along the north-eastern side of that road to a point in line with the western boundary of Section 6, Block XIII, Upper Waitara Survey District; thence southerly to and along the western boundary of that section and the western boundary of Section 9 to the northern boundary of Section 2 all Block XIII, Upper Waitara Survey District; thence westerly generally along the northern boundaries of Sections 2 and 1, Block XIII, aforesaid, and Sections 7, 6, and 5, Block XVI, Waitara Survey District, and the last-mentioned boundary produced to the western side of Mataro Road; thence northerly and westerly along that side of Mataro Road, to and westerly along the northern side of Taramoukou Road to the eastern boundary of Section 21, Block XV, Waitara Survey District; thence northerly along the eastern boundary of that section to and westerly along the northern boundaries of the said Section 21, and Sections 20 and 12, Block XV, aforesaid, and the last-mentioned boundary produced to the western side of Otaraoa Road; thence southerly generally along the western side of that road to the south-eastern boundary of Lot 7, D.P. 658; thence south-westerly along the south-eastern boundary of the said Lot 7 to and along the southern boundary of Section 14, Block XIV, Waitara Survey District; thence south-westerly along the south-eastern boundary of Lot 7, D.P. 658, and the last-mentioned boundary produced to the middle of the Waitara River; thence north-westerly generally down the middle of that river to a point on the boundary of the Borough of Waitara due east of the confluence of the Mangahinau Stream with the Waitara River; thence south-easterly and northerly generally along the south-western and eastern boundaries of the Borough of Waitara as hereinbefore described to the sea coast; thence north-easterly generally along the sea coast to the point of commencement.

BOUNDARIES OF TIKORANGI RIDING OF COUNTY OF CLIFTON

ALL that area in the Taranaki Land District, County of Clifton bounded by a line commencing at a point on the sea coast and the western boundary of part Ngatirahiri 4J, Block II, Waitara Survey District, and proceeding southerly along the western boundaries of the said part Ngatirahiri 4J and Ngatirahiri 4A, 4B, and part 4H to the northern side of the Main North Road; thence by a right line across that road to and along the western boundaries of Ngatirahiri Part 4U, Lot 1, D.P. 7153, Sections 21, 22, and 23, Tikorangi District in Block VI, Waitara Survey District, to the south-western corner of the said Section 23; thence north-easterly and south-easterly along the northern and eastern boundaries of Sections 18 and 17, Tikorangi District, to the northern side of the Inland North Road; thence by a right line across that road to and along the eastern boundaries of Sections 28 and 41, Tikorangi District, to the northern side of Tikorangi Road; thence by a right line across that road to and along the eastern boundaries of Sections 61 and 62, Tikorangi District, to the western side of the Allen Road; thence southerly generally along the western side of the Allen Road to the easternmost corner of Ngatirahiri 9A; thence by right line across the Allen Road to the boundary of Ngatirahiri 11C at the intersection of Allen Road and Ohanga Road; thence southerly generally along the western boundary of Ngatirahiri 11C to the northern boundary of Ngatirahiri 11B; thence westerly, southerly, and easterly generally along the northern, western, and southern boundaries of the said Ngatirahiri 11B and Section 36, Block XI, Waitara Survey District, and the production of the last-mentioned boundary to the middle of the Onaero River; thence southerly generally up the middle of that river to a point in line with the northern boundary of Section 12, Block XV, Waitara Survey District; thence westerly and northerly generally along the boundary of the County of Clifton hereinbefore described to the intersection of the last-mentioned boundary with the southern boundary of the Borough of Waitara; thence easterly and northerly generally along the boundary of the Borough of Waitara hereinbefore described to the sea coast; thence easterly generally along the sea coast to the point of commencement.

BOUNDARIES OF URENUI RIDING OF COUNTY OF CLIFTON

ALL that area situated in the County of Clifton bounded by a line commencing on the sea coast at a point due west of the northern side of Gilbert Road situated in Block VII, Mimi Survey District, and proceeding due east to and generally easterly along the northern side of Gilbert Road to a point due north of the eastern boundary of Section 1, Block VII, Mimi Survey District; thence along a right line to and generally southerly and south-westerly along the eastern and south-eastern boundaries of that section to the eastern boundary of Block VI, Mimi Survey District; thence southerly generally along the eastern boundary of the said Block VI and the eastern boundary of Block X, Mimi Survey District, to the northern side of Waititi Road; thence easterly and southerly along the northern and eastern sides of Waititi Road to a point in line with the eastern boundary of Section 15, Block I, Upper Waitara Survey District; thence southerly to and along the eastern boundary of that section to and south-easterly generally along the north-eastern boundaries of Section 28, Block I, and Section 12, Block II, Upper Waitara Survey District, and the last-mentioned boundary produced to the south-western side of Mangamaio Road; thence south-easterly generally along the south-western side of Mangamaio and Kaka Roads to the eastern boundary of Section 8, Block VI, Upper Waitara Survey District; thence southerly and westerly along the eastern and southern boundaries of that section and the last-mentioned boundary produced to the western side of Okoki Road; thence southerly generally along the western side of Okoki Road to the western boundary of Section 2, Block X, Upper Waitara Survey District; thence southerly generally along the western boundary of that section and Section 1 of the said Block X to the northern boundary of Section 18, Block XIV, Upper Waitara Survey District; thence westerly along the northern boundary of the said Section 18 to Mangapito Road; thence south-easterly along the north-eastern side of Mangapito Road to a point due north of the western boundary of Section 6, Block XIII, Upper Waitara Survey District; thence southerly along a right line to and along the western boundaries of the said Section 6 and Section 9, Block XIII, Upper Waitara Survey District, to and westerly along the northern boundaries of Sections 2 and 1 of the said Block XIII to and again westerly along the northern boundaries of Sections 7, 6, and 5, Block XVI, Waitara Survey District, and the last-mentioned boundary produced to the western side of Mataro Road; thence northerly along the western side of Mataro Road to and northerly along the western side of Kaipikari Road to the southern boundary of Section 8, Block XII, Waitara Survey District; thence westerly and northerly along the southern and western boundaries of that section and the western boundary of Section 1, Block XII, aforesaid and its production across Matapo Road to and generally northerly along the western side of that road to and again northerly along the eastern boundary of Section 43, Block XI, Waitara Survey District, to and westerly along its northern boundary to and north-westerly generally along the north-eastern boundary of Section 3, Block VII, Waitara Survey District, to Tikorangi Road; thence northerly generally along a right line across that road to and along the eastern boundary of Section 39 and the southern and eastern boundaries of Section 42, Urenui District, and the last-mentioned boundary pro-
