

the said public road; thence generally southerly along the middle of the public road forming the eastern boundaries of Sections 24 and 23, Block XII, Waipahi Survey District, and the eastern boundaries of Block II, Slopedown Survey District, to the middle of a public road forming the northern boundary of Section 2, Block VI, Slopedown Survey District; thence north-easterly along the middle of that road to a point in line with the eastern boundary of Section 2 aforesaid; thence southerly to and along that boundary and south-westerly along the south-eastern boundary of Section 2, aforesaid, to the north-eastern boundary of Run 251; thence generally south-easterly and south-westerly along the north-eastern and south-eastern boundaries of Run 251 to a point in line with the north-eastern boundary of Section 6, Block VII, Slopedown Survey District; thence south-easterly along a right line to the northernmost corner of the said Section 6; thence generally south-westerly along the north-western and western boundaries of the said Section 6 and the production of the last-mentioned boundary to the middle of the Mokoreta (or Wyndham) River; thence south-westerly down the middle of that river to a point in line with the eastern boundary of Section 5, Block VI, Mokoreta Survey District; thence generally south-easterly to and along the eastern and north-eastern boundaries of the said Section 5 and the production of the last-mentioned boundary to the northernmost corner of Section 6, Block VI, aforesaid; thence south-easterly along the north-eastern boundary of the said Section 6, to peg No. XIII; thence south-westerly along a right line to Trig Station H. (Chimney); thence generally south-easterly along the watershed passing through Trig Station G, Bleak Hill, Mount Alfred, and Table Ridge to Trig Station EE in Block XIV, Mokoreta Survey District; thence due south to the north-eastern side of a road forming the north-eastern boundaries of Sections 2, 3, and 5, Block XIV, aforesaid; thence south-easterly along the north-eastern side of that road to a point in line with the eastern boundary of the said Section 5; thence southerly to and along that boundary to the northern boundary of Waikawa Survey District; thence easterly and southerly along the northern and eastern boundaries of Waikawa Survey District to the northern side of No. 92 State Highway; thence south-easterly along the northern side of that highway to the middle of Longbeach Creek; thence generally south-easterly down the middle of Longbeach Creek to the point of commencement; excluding therefrom that portion of the Borough of Balclutha, as described by *Gazette*, 1955, page 1093, which comes within the above-described area.

BOUNDARIES OF CLYDEVALE RIDING OF COUNTY OF CLUTHA

ALL that area in the Otago Land District, Clutha County, bounded by a line commencing at the confluence of the Clutha and Pomahaka Rivers being a point on the boundary of the County of Clutha hereinbefore described; thence generally north-westerly and south-westerly along that boundary to the confluence of Back Creek (East Branch) and the Pomahaka River; thence down the middle of that river to the point of commencement.

BOUNDARIES OF GLENKENICH RIDING OF COUNTY OF CLUTHA

ALL that area in the Otago Land District, Clutha County, bounded by a line commencing at the north-western corner of Block IX, Glenkenich Survey District, and proceeding easterly along the northern boundary of that block to the middle of Waikoiko Road; thence generally south-easterly along the middle of that road and north-easterly along the middle of No. 90 State Highway to the middle of a road forming the western boundaries of Sections 55 and 58, Block X, Glenkenich Survey District; thence southerly along the middle of that road and generally south-easterly along the middle of a road forming the generally southern boundaries of Sections 58, 18, 16, 15, 14, 11, and 39, Block X, aforesaid and intersecting Sections 3 and 4, Block XVI, Glenkenich Survey District, to the middle of the Pomahaka River being a point on the boundary of the County of Clutha hereinbefore described; thence generally north-westerly and southerly along that boundary to the point of commencement.

Boundaries of County of Tuapeka, Beaumont Riding of County of Tuapeka, and Crookston Riding of County of Tuapeka, Defined

PURSUANT to section 16 of the Counties Act 1956, the Secretary for Internal Affairs hereby defines, as set out in the Schedule hereto, the boundaries of the County of Tuapeka, and the Beaumont and Crookston Ridings of the County of Tuapeka; the previous boundaries having been altered by Orders in Council made on 8 March 1965, and published in *Gazette*, 18 March 1965, No. 13, page 340; and on 22 September 1965, and published in *Gazette*, 30 September 1965, No. 56, page 1652.

SCHEDULE

COUNTY OF TUAPEKA

ALL that area in the Otago and Southland Land Districts bounded by a line commencing at Trig Station "F" at the south-western corner of Block XII, Waipori Survey District, and proceeding westerly along the northern boundary of Block

XII, Maungatua Survey District, and southerly along the western boundary of that block and Blocks XIII and XV, Maungatua Survey District, and the production of the western boundary of that Block XV to the middle of the Waipori River; thence generally south-easterly down the middle of that river to the south-eastern boundary of Block X, Waipori Survey District; thence south-westerly along that boundary to the northern side of an undefined road intersecting Run 51A; thence generally westerly along the northern side of that road to the easternmost corner of Section 5, Block IX, Waipori Survey District; thence north-westerly along the north-eastern boundary of that section to the northernmost corner of that section; thence generally southerly along the eastern boundary of Section 1, Block IX, aforesaid to the north-western side of a road intersecting Section 1, aforesaid; thence generally south-westerly along the north-western side of that road to the northern boundary of Section 1, Block IX, Table Hill Survey District; thence generally south-westerly along the north-western side of a road intersecting that Section 1, Section 21, Block VII, Tuapeka East Survey District, again Section 1, Block IX, Table Hill Survey District, and Section 16, Block XI, Table Hill Survey District, to the western boundary of that Section 16; thence generally southerly along the eastern boundary of Section 11, Block XI, aforesaid, to its southernmost corner; thence due south to the eastern boundary of Section 4, Block XI, aforesaid; thence south-westerly along the south-eastern side of a road intersecting that Section 4 to the north-western corner of Section 11, Block VII, Table Hill Survey District; thence due west to the north-eastern corner of Section 23, Block VII, aforesaid; thence generally south-westerly along the north-western side of a road forming the eastern and south-eastern boundaries of Sections 23, 22, 27, 1, and 28, Block VII, aforesaid to the south-western corner of the said Section 28; thence due south to the north-eastern boundary of Section 74, Block V, Waitahuna East Survey District; thence generally south-easterly along the north-eastern boundaries of Sections 74 and 73, Block V, aforesaid, and Section 13, Block IV, Waitahuna East Survey District, to the north-eastern corner of the last-mentioned Section; thence southerly and generally south-westerly along the eastern and south-eastern boundaries of Block IV, Waitahuna East Survey District, to the southernmost corner of that Block IV; thence north-westerly along the south-western boundaries of Blocks IV and VI, Waitahuna East Survey District, and the production of the last-mentioned boundary to and along the south-western boundaries of Sections 18, 17, 16, 15, 14, and 3, Block VII, Waitahuna West Survey District, and the production of the last-mentioned boundary to and along the south-western boundaries of Section 1, Block VII, aforesaid and Section 1, Block IX, Waitahuna West Survey District, to the northernmost corner of Section 15, Block IX, aforesaid; thence generally south-westerly along the south-eastern side of Waitahuna West Road to a point in line with the south-western boundary of Section 13, Block XI, Waitahuna West Survey District; thence north-westerly to and along that boundary to the middle of the Crook Burn; thence generally south-westerly down the middle of that burn to its confluence with the Clutha River; thence generally north-westerly up the middle of that river to its confluence with the Blackcleugh Burn; thence generally north-westerly up the middle of that burn to the northern boundary of Block VI, Rangleburn Survey District; thence generally westerly and southerly along the northern and western boundaries of that block to a point due west of Trig Station "D", in Section 38, Block VI, Rangleburn Survey District; thence due west to the middle of Back Stream (East Branch); thence generally south-westerly down the middle of that stream to its confluence with the Pomahaka River; thence generally south-westerly and north-westerly up the middle of that river to a point bearing 29° from the southernmost corner of the land shown on D.P. 5574, Block III, Greenvale Survey District; thence south-westerly along a right line to that corner; thence north-westerly along the south-western boundaries of the land shown on D.P. 5574 to the westernmost corner of that land; thence due north to the middle of the Pomahaka River; thence generally north-westerly up the middle of that river to its confluence with the Leithen Burn; thence generally north-westerly up the middle of that burn and its westernmost tributary to a point due east of road corner peg LV on S.O. Plan 570 on the north-eastern side of a road forming the south-western boundary of Run 687; thence due west to that peg; thence north-westerly along the south-western boundary of that run to a point due south of Trig Station "K", Black Umbrella; thence due north to that trig station; thence generally north-easterly along the summit of the Umbrella Mountains to a point due east of Trig. Station "T", Rocky Mountain Obelisk Survey District; thence due east to the south-western boundary of Run 2621, Teviot Survey District, on the summit of the Knobby Range; thence generally south-easterly along that boundary and the south-western boundary of Run 569 to the westernmost corner of Run 1991; thence generally south-easterly and easterly along the south-western and southern boundaries of that run to the northernmost corner of Run 199K; thence south-easterly along the south-western boundary of Run 569 to its southernmost corner; thence generally south-easterly along the summit of a leading ridge passing through Trig Station "X" in Run 641 to peg XVIII, S.O. Plan 920, on the south-eastern boundary of that Run 641; thence generally southerly along the western boundary of Run 642 to the north-western side of a road; thence north-easterly, south-easterly and generally north-easterly along the north-western, north-eastern and north-western sides of that road to Trig. Station "C" on the eastern boundary of Run 642, Long Valley Survey District; thence generally north-easterly, easterly, south-easterly and south-westerly along the summit of a leading ridge passing through Runs 643 and
