Station L; thence northerly along the eastern boundary of Block XIV aforesaid to the northern boundary of Run 708; thence generally north-easterly along that boundary and the north-western boundary of Section 3, Block XVI, Crookston Survey District, to the southern boundary of Section 4, Block XVI, aforesaid; thence easterly along that boundary and its production to the middle of the Belle Burn; thence generally easterly down the middle of the Belle Burn to a point in line with the northern boundary of Section 2, Block I, Crookston Survey District; thence easterly to and along that boundary and the northern boundaries of Eden Street and Sections 5 and 4, Block XV, Town of Dunkeld, to the north-eastern corner of the said Section 4; thence southerly along the western side of Carron Street to the southern side of Don Street; thence easterly and southerly along the southern side of Don Street and the western side of Allanhead Street to a point in line with the northern boundary of Block X, Town of Dunkeld; thence easterly to and along that boundary and southerly along the eastern boundary of that Block to the northern side of the No. 8 State Highway; thence easterly along that side to the western boundary of Section 30, Block III, Beaumont Survey District; thence south-easterly along a right line to the north-western corner of Section 1, Block III, aforesaid; thence generally easterly along the southern side of the road forming the northern boundaries of Sections 1 and 2, Block III, aforesaid and passing through Run 523 to the north-eastern boundary of Block I, Beaumont Survey District; thence south-easterly along that boundary and the north-eastern boundary of Run 686 to the southern boundary of Block VIII, Beaumont Survey District; thence easterly along that boundary and its production to the middle of the Tuapeka River; thence generally southerly down the middle of the Tuapeka River to the northern boundary of Block XIX, Tuapeka East Survey District; thence generally easterly along that boundary and the northern boundary of Block X, Tuapeka East Survey District, to the western boundary of Block IX, Tuapeka East Survey District; thence northerly along the western boundaries of Blocks IX and XII, Tuapeka East Survey District, and easterly along the northern boundary of the said Block XII to the north-eastern boundary of Run 494; thence north-westerly along that boundary and its production to the middle of the Waipori River; thence generally north-westerly up the middle of that river to its confluence with Deep Stream; thence generally north-easterly up the middle of that stream to a point in line with the south-eastern boundary of Run 525; thence generally north-easterly to and along that boundary and generally north-westerly along the north-eastern boundaries of Runs 525 and 527 to the northernmost corner of Run 527; thence generally northerly along the watershed through Trig. Station H (Lammerlaw Top) Lammerlaw Survey District, Q (Davidsons Top) St. Abbs Survey District, D, (Bottle Rock), F, Y, and V, Long Valley Survey District, and H, Manorside Survey District, to C (South Rough Ridge Hill) Manorside Survey District; thence north-easterly along a right line between Trig. Station C (South Rough Ridge Hill) and W, Manorside Survey District, to its intersection with the south-western boundary of Section 1, Block V, Manorside Survey District; thence north-westerly along that boundary and generally northerly along the western boundaries of Section 1, Block V, aforesaid, Section 1, Block III, Manorside Survey District, Lot 4, D.P. 9807, Runs 622 and 621, and Section 1, Block IX, Poolburn Survey District, and the last-mentioned boundary produced to the south-western boundary of Section 3, Block XI, Gimmerburn Survey District; thence generally north-easterly along the north-western boundary of Sections 3 and 2, Block XI, aforesaid, Runs 261k and 225w, Sections 9, 6, and 7, Block X, Gimmerburn Survey District, Section 3, Block IX, Gimmerburn Survey District, and Run 225AA to the easternmost corner of Section 3, Block VI, Poolburn Survey District; thence westerly along the northern boundary of that section to and north-westerly along the south-western boundaries of Section 2, Block XVII, Blackstone Survey District and Sec-

tion 24, Block XVI, Blackstone Survey District to the south-eastern side of the Ida Valley Back Road; thence south-westerly along that side of the road to a point in line with the eastern boundary of Block XV, Blackstone Survey District; thence northerly to and along that boundary and south-westerly along the north-western boundary of the said Block XV to a point in line with the south-western boundary of Run 224x, Block XII, Blackstone Survey District; thence north-westerly to and along that boundary to the westernmost corner of Run 224x; thence north-easterly along the north-western boundaries of Runs 224x and 224y to the southernmost corner of Run 224A; thence north-westerly along the south-western boundary of Run 224A to the westernmost corner of that run; thence north-westerly by a right line to the confluence of the Manuherikia River and the Dunstan Creek; thence generally northerly up the middle of that creek to the southern boundary of Block II, St. Bathans Survey District; thence easterly, northerly, and westerly along the southern, eastern, and northern boundaries of Block II aforesaid to the middle of the Dunstan Creek; thence generally north-westerly up the middle of that creek to a point on the right line between Geodetic Trig. Station (Nicholas Peak) Block IX, St. Bathans Survey District, and Trig. Station AA (Mount St. Bathans) Block XVI, St. Bathans Survey District; thence north-easterly along that right line to Trig. Station AA aforesaid; thence easterly along the northern boundaries of St. Bathans and Turnagain Survey Districts to the summit of the Hawkdun Range; thence generally south-easterly along that summit to Trig. Station I (Mount Ida); thence generally easterly along the southern boundary of Run 573 to the western side of Mount Buster Road; thence generally easterly to and along the watershed running across the south-western corner of Run 574 to the south-eastern boundary of Run 574; thence generally north-easterly along the south-eastern boundary of Run 574 to the watershed running across the north-eastern corner of Run 576; thence generally south-easterly along that watershed to Trig. Station Y, Block IX, Kyeburn Survey District; thence generally southerly along the eastern boundary of Run 576 to Dansey Pass; thence generally southerly along the western boundary of Run 510 and generally south-easterly along the north-eastern boundaries of Runs 206b, 206d, 206e, and 203c to Trig. Station A (Kakanui Peak); thence generally southerly along the western boundaries of Run 682 and Section 1, Block XV, Kakanui Survey District to peg XV on S.O. Plan 701; thence north-easterly along a right line to peg XI on the eastern boundary of the said Section 1; thence generally south-easterly along the south-western boundaries of Runs 571, 572, and 699 to the south-eastern corner of Section 1, Block IX, Waihemmo Survey District; thence generally south-easterly along a leading ridge through Run 699 to a point 4,000 links along the south-eastern boundary of Run 699 from the northernmost corner of Section 24, Block VIII, Waihemmo Survey District; thence generally south-westerly along the south-eastern boundary of Run 699 to the northernmost corner of Section 24, Block VIII aforesaid; thence generally south-easterly along the north-eastern boundaries of Blocks VIII, V, and III, Waihemmo Survey District to the easternmost corner of the said Block III; thence south-westerly along the south-eastern boundary of that block to the north-eastern side of Razorback Track; thence generally south-easterly along the north-eastern side of Razorback Track to the eastern boundary of Block XV, Moeraki Survey District; thence southerly along the eastern boundaries of Blocks XV and VIII, Moeraki Survey District to a point in line with the north-eastern side of Razorback Track, Block XIV, Moeraki Survey District; thence generally south-easterly to and along the north-eastern side of Razorback Track to a point in line with the western boundary of Section 3, Block XIV, aforesaid; thence southerly to and along that boundary to the northern boundary of Block XII, Moeraki Survey District; thence easterly and southerly along the northern and eastern boundaries of Block XII aforesaid to the northern boundary of Block VI, Moeraki Survey District; thence easterly along that boundary to the north-eastern corner of Block VI aforesaid; thence north-easterly and south-easterly along the south-eastern and south-western sides of the road which forms the north-eastern boundary of Section 31, Block XI, Moeraki Survey District to the western side of Horse Range Road; thence generally southerly along the western side of that road to a point in line with the south-western side of the closed road along the summit of Horse Range; thence generally south-easterly to and along that side of the closed road to the generally northern boundary of Block III, Moeraki Survey District; thence generally easterly along that boundary to the sea coast; thence generally south-westerly along the sea coast to a point in line with the eastern boundary of Section 67, Block V, North Harbour and Blueskin Survey District; thence southerly to and along that boundary to a point 1,040 links from the south-eastern side of Heyward Point Road; thence generally south-westerly along a line 10 chains from and parallel to that side of the road to a point in line with the southern boundary of Section 2, Block VI, North Harbour and Blueskin Survey District; thence westerly to and along that boundary to the south-western corner of that section; thence northerly along the western boundary of Block VI aforesaid to the southern boundary of Block I, North Harbour and Blueskin Survey District; thence westerly and northerly along the southern and western boundaries of Block I aforesaid to the south-western side of Miller Road; thence north-westerly along that roadside and
