*Boundaries of City of Takapuna, Borough of Devonport, and Borough of Northcote, Defined*

PURSUANT to section 26 of the Municipal Corporations Act 1954, the Secretary for Internal Affairs hereby defines, as set out in the Schedule hereto, the boundaries of the City of Takapuna, the Borough of Devonport, and the Borough of Northcote; the previous boundaries having been altered by Orders in Council made on 17 August 1966, and published in *Gazette*, 18 August 1966, No. 49, page 1302; and on 11 October 1967, and published in *Gazette*, 12 October 1967, No. 64, page 1770.

## SCHEDULE

## BOUNDARIES OF CITY OF TAKAPUNA

ALL that area of approximately 3,282 acres in the North Auckland Land District, bounded by a line commencing at a point on the line of mean high water along the shores of the Hauraki Gulf in Block VIII, Waitemata Survey District, being the south-eastern corner of Lot 3, D.P. 44038, and proceeding

southerly generally along the said line of mean high water, crossing the mouth of the Wairau Creek, to a point in Block VI, Rangitoto Survey District, being the northernmost corner of Lot 17, D.P. 7449; thence westerly generally along the northern boundary of that lot and along a right line across Hamana Street to the northernmost corner of Lot 18, along the northern boundaries of that lot and Lot 48 and along a right line across Merani Street to the northernmost corner of Lot 49; thence along the northern boundaries of the last-mentioned lot and Lot 77, the northern end of Hemi Street, and the northern boundary of Lot 78, all the aforesaid lots being shown on D.P. 7449; along the northern boundary of Lot 11, Deeds Plan 97, along a right line across Wicklow Road to the northernmost corner of Lot 10, Deeds Plan 97; thence still westerly generally along the northern boundaries of the last-mentioned lot and Lots 14, 13, 12, 8, and 4, D.P. 37880, and Lot 1, D.P. 38166, to Lake Road; thence south-westerly generally along a right line across Lake Road to the northernmost corner of Lot 2, D.P. 30904 and along the north-western and south-western boundaries of that lot and the south-western boundary of Lot 2, D.P. 40447, to and along the north-western boundaries of Lots 6, 7, 10, 11, 14, 16, 17, and 18, D.P. 46166, Lot 1, D.P. 52609, Lot 2, D.P. 52518, and Lot 24, D.P. 46166, to and along the line of mean high water along the northern shores of Ngataranga Bay and continuing along the line of mean high water as shown on D.P. 4787 to a point in line with the south-western boundary of Lot 1, D.P. 20033; thence to and along that boundary and the south-western, north-western, and north-eastern boundaries of Lot 1, D.P. 17189, and the north-eastern boundaries of Lots 1 and 2, D.P. 20033, and the last-mentioned boundary produced to and north-easterly along the said line of mean high water shown on D.P. 4787 and continuing along the line of mean high water along the generally eastern shores of Shoal Bay to and along the eastern boundary of Lot 1, D.P. 20076, and continuing along the line of mean high water as shown on D.P. 19922 to the westernmost corner of the land shown on the said D.P. 19922; thence again along the line of mean high water along the shores of Shoal Bay to and along the line of mean high water as shown on D.P. 4526, and again along the line of mean high water along the shores of Shoal Bay to the southernmost corner of an area of 1 acre 2 roods 39 perches taken for road by Proclamation published in *Gazette*, 1960, pages 313, and shown on S.O. Plan 41819; thence along the western and northern boundaries of that area and continuing along the line of mean high water along the generally eastern and northern shores of Shoal Bay to and along the line of mean high water shown on D.P. 8038 and continuing along the line of mean high water along the aforesaid northern shores to and along the line of mean high water shown on D.P. 4553 to its intersection with the north-eastern boundary of an area of 2 acres 1 rood 1 perch, being part of the Auckland-Albany Motorway and adjoining reclaimed land shown on S.O. Plan 45062; thence south-easterly, south-westerly, and then north-westerly generally along the north-eastern, south-eastern, and generally south-western boundaries of that area, to and continuing westerly generally along the southern boundary of Allotment 381, Takapuna Parish, to and south-westerly along the south-eastern boundary of Lot 1, D.P. 31225, to the southernmost corner of that lot; thence north-westerly along the south-western boundary of the said Lot 1 and along a right line across Northcote Road to the southernmost corner of Allotment 482, Takapuna Parish, and along the south-western boundaries of that allotment, of Allotment 483, Takapuna Parish, and of Lots 2 and 1, D.P. 53045, the south-western end of Porana Road, and the south-western boundaries of Lots 1 and 3, D.P. 41292, and Lots 17, D.P. 8521, to and north-easterly along the south-eastern side of Archers Road to the northernmost corner of Lot 9, D.P. 48491; thence along a right line across Archers Road to the southernmost corner of Lot 48, D.P. 47481 (now dedicated road), and along the south-eastern boundary of that lot and the north-western sides of Archers Road and Forrest Hill Road to the easternmost corner of Lot 2, D.P. 21594, and along a right line across Forrest Hill Road to the western corner of Lot 137, D.P. 8886; thence still north-easterly along the north-western boundary of that lot, along a right line across Corunna Road to the southernmost corner of Lot 21, D.P. 51550, and along the south-eastern boundaries of the last-mentioned lot and of Lots 16 and 15, D.P. 51550, and Lot 27, D.P. 52216, to Nile Road; thence along a right line across that road to the southernmost corner of Lot 7, D.P. 45968, and northerly generally along the south-western boundary of that lot to and along the eastern boundaries of Lots 26, 25, 24, 23, 22, 21, 20, and 19, D.P. 52216, and Lots 58, 57, 56, 55, 54, 53, 52, and 51, D.P. 52972, along a right line across Marsh Avenue to the easternmost corner of Lot 89, D.P. 53364, and along the eastern boundaries of the last-mentioned lot and of Lots 88, 87, and 85, D.P. 53364, and continuing along the generally eastern boundaries of Lot 12, D.P. 12173, to the north-western corner of Lot 10, D.P. 33966; thence along the production of the western boundary of the said Lot 10 to and north-easterly along the south-eastern boundary of Allotment 249, Takapuna Parish, to East Coast Road, and across that road to the southernmost corner of Allotment 250, Takapuna Parish; thence along the south-eastern boundary of that allotment to the northernmost corner of Lot 1, D.P. 30028, and south-easterly generally along the north-eastern boundary of that lot to a public street and along a right line across Beach Road to the south-western corner of Lot 3, D.P. 44038; thence easterly along the southern boundary of that lot to the point of commencement.
