Fire Brigade Loan (No. 2) 1967, \$8,000

PURSUANT to the Local Authorities Loans Act 1956, the Roxburgh Borough Council hereby resolves as follows:

Consolidation of Special Rates

NOTICE is hereby given that the following resolution intended to operate as a special order, was passed at a special meeting of the Mount Roskill Borough Council convened for that purpose and held on the 6th day of February 1968 and was confirmed at an ordinary meeting of the Mount Roskill Borough Council held in the Municipal Chambers, Three Kings, Mount Roskill, at 7.35 p.m. on Tuesday, 5 March 1968.

Resolution

"That, in pursuance and exercise of the powers vested in it by section 108A of the Municipal Corporations Act 1954 as enacted by section 10 of the Municipal Corporations Amendment Act 1959 and all other powers enabling it in that behalf, the Mount Roskill Borough Council hereby resolves, by way of special order, that instead of levying the special rates specified in the Schedule hereto, to make a uniform consolidated special rate of one decimal nine three two five cents (1.9325c) in the dollar (\$) on all rateable property within the Borough of Mount Roskill, and the same is hereby made an annually recurring rate for the purpose of paying the annual charges plus ten percent (10%) thereof, payable in respect of the loans secured by those special rates.

And the Mount Roskill Borough Council hereby further resolves that the consolidated special rate shall be payable in one sum on the 1st day of April in each year at the Council Chambers, corner Three Kings and Mount Albert Roads, Mount Roskill to George Walter Stephenson or at such other place, or to such other person for the time being authorised by Council.
