

easterly and generally southerly along the northern and generally eastern boundaries of that Block, and crossing the intervening State Highway No. 30, Maraeroa A2 Block to Trig. 1390, Pureora, aforesaid; thence generally south-westerly along a right line to the source of the Ongarue River, situated in Block VII, Hurakia Survey District; thence generally westerly down the middle of that last-named river to a point in line with the western boundary of Ketemaringi No. 1 Block; thence northerly to and along that last-named boundary and the generally western boundary of part Maraeroa C Block to and generally westerly along the generally southern boundaries of Rangitoto-Tuhua 36A 1A 2 and Rangitoto-Tuhua 36A 1B 2A 2 Blocks, to and again generally westerly along the generally southern boundaries of Section 1, Block II, Ongarue Survey District, to and generally westerly along a right line crossing the Waimiha River, to and generally westerly along the southern boundaries of Sections 7 and 5, Block III, Pahi Survey District to the south-westernmost corner of the last-mentioned Section; thence generally southerly and generally westerly along the eastern and southern boundaries of Section 3, Block III, aforesaid, to and generally westerly along the southern boundary of Section 4, Block III aforesaid, to the south-westernmost corner of that last-mentioned Section; thence generally southerly and generally westerly along the eastern and southern boundaries of Blocks XIV and XIII, Mapara Survey District, to a point on the southern boundary of Block XIII aforesaid, being the south-westernmost corner of Lot 1, D.P. 7475 (Taranaki Land Registry), situated in Block XIII aforesaid; thence generally southerly along the eastern boundaries of Rangitoto-Tuhua 77B 2B 2, 77B 2B 1, part 77B 2A, and 77B 1B 1 Blocks, to a point on the northern side of Takiri Road; thence generally westerly along the northern side of Takiri Road to the eastern side of a public road passing through part Section 2, Block III, Tangitu Survey District; thence generally southerly along a right line being the production of the eastern side of the aforesaid public road across Takiri Road to its southern side; thence generally westerly along the southern side of Takiri Road to and across Paraketu Road; thence north-westerly along the south-western side of Takiri Road to and generally south-westerly along the south-eastern boundary of Section 18, Block II, Tagitu Survey District to its southernmost corner, thence generally westerly along the southern boundaries of Blocks II and I, Tangitu Survey District and Blocks IV and III, Aria Survey District; thence generally southerly and generally westerly along the eastern and southern boundaries of Block VI, Aria Survey District to and generally northerly along the western boundary of Section 9, Block VI aforesaid; thence generally westerly along the southern boundaries of Sections 6 and 15, Block VI aforesaid, and the last-mentioned boundary produced to the middle of the Waitewhena Road; thence generally southerly along the middle of that road to a point in line with the southern boundary of Section 8, Block V, Aria Survey District; thence to and generally westerly and generally northerly along the southern and western boundaries of the said Section 8, Block V aforesaid, to and generally westerly along the southern boundaries of Lot 1, D.P. 8793, and Section 2, Block V aforesaid, to the south-western corner of the aforesaid Section 2; thence generally southerly and generally westerly along the eastern and southern boundaries of Section 11, Block V aforesaid, to and generally southerly along the western boundary of Aria Survey District and its production to the middle of the Panirau Stream; thence generally south-westerly down the middle of the said Panirau Stream to its confluence with the Mokau River, situated in Block V, Mokau Survey District; thence down the middle of that river to a point in line with the north-eastern boundary of Subdivision 2 of Section 3, Block III Mokau Survey District; thence to and generally south-easterly along the north-eastern boundary of Subdivision 2 of Section 3, Block III aforesaid, to and generally southerly and south-westerly along the eastern and south-eastern boundaries of part Section 3, Block III aforesaid, to the eastern boundary of Section 8 of the said Block III; thence southerly along that boundary to the south-eastern corner

of the said Section 8; thence generally westerly and northerly along the southern and western boundaries of Section 8, Block III, aforesaid to and generally westerly along the generally southern boundary of part Lot 5, D.P. 3836 (Taranaki Land Registry), and that boundary produced to the middle of the Mokau River; thence generally westerly down the middle of that river to the point of commencement; excluding therefrom the Borough of Te Kuiti as described in *N.Z. Gazette*, 1928, page 714.

BOUNDARIES OF TANGITU RIDING OF COUNTY OF WAITOMO.

ALL that area in the South Auckland and Taranaki Land Districts, County of Waitomo, bounded by a line commencing at the north-western corner of Section 7, Block IV, Aria Survey District, being a point on the boundary of the County of Waitomo, and proceeding generally easterly along the generally northern boundary of the said Section 7, Block IV aforesaid; to and northerly along the western boundaries of Sections 6, 3, 2, and 1, Block IV aforesaid, to the southern boundary of part Lot 9, D.P. 5513 (Taranaki Land Registry); thence easterly along the southern boundary of the said part Lot 9, D.P. 5513 aforesaid, to and across Kakara Road and along the southern boundary of Lot 10, D.P. 5513, to the south-eastern corner of that lot being a point on the boundary between Aria and Tangitu Survey Districts; thence generally northerly along that boundary and the boundary between Mapara and Totoro Survey Districts to the northern boundary of Rangitoto-Tuhua 72B 1A Block situated in Block VII, Mapara Survey District; thence easterly along the northern boundary of that block to and southerly along its eastern boundary to the southern boundary of Rangitoto-Tuhua 72B 1B 1B Block; thence generally easterly along the southern boundary of that block to its easternmost corner; thence northerly along the eastern boundary of part Rangitoto-Tuhua 72B 2 Block to the middle of an unnamed public road forming the northern boundary of Section 4, Block III, Mapara Survey District; thence generally easterly along the middle of that road to and along the middle of Mapara Road, crossing Kopaki Road and again along the middle of Mapara Road to a point in line with the southern boundary of Section 1, Block VIII, Mapara Survey District; thence easterly to and along that boundary to and generally north-easterly along the south-eastern boundary of that section and northerly along its eastern boundary and the eastern boundary of Section 7, Block IV, Mapara Survey District, to Kopaki Road; thence along a right line across that road to and along the eastern boundary of Section 4, Block IV, aforesaid to its easternmost corner, thence along the southern boundary of Lot 5, D.P. 5352, to the western side of the North Island Main Trunk Railway; thence along a right line across that railway to the south-western corner of May Street, thence again easterly along the southern side of that street to the western side of State Highway No. 30; thence easterly along a right line across that highway to and along the southern boundary of part Lot 2, D.P. 8332, to and generally northerly along its eastern boundary and that boundary produced to the middle of the Mokau River; thence generally easterly up the middle of the said Mokau River and a tributary of the Mokau River to the generally south-western boundary of Rangitoto-Tuhua, 36A 2C 2 Block, situated in Block XVI, Pakaumanu Survey District; thence generally south-easterly and generally north-easterly along the generally south-western and generally south-eastern boundaries of the said Rangitoto-Tuhua 36A 2C 2 Block to the generally south-western boundary of Rangitoto-Tuhua 36A 2C 7 Block; thence generally south-easterly along the generally south-western boundary of that Block and 36A 2C 8 Block and generally north-easterly along the generally south-eastern boundaries of the last-named Block, parts Rangitoto A 31A Block and Rangitoto A 31B Block to its intersection with the boundary of the County of Waitomo, as hereinbefore described; thence generally south-easterly and westerly along that county boundary to the point of commencement.
