1. This notice may be cited as the Control of Prices (Positive List) 1966, Amendment No. 5, and shall be read together with and deemed to be part of the Control of Prices (Positive List) 1966\* (hereinafter referred to as the principal notice).

3. The principal notice is hereby amended as follows:
