PURSUANT to the Fire Services Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. The area described in the Schedule hereto, comprising the area of the New Plymouth Urban Fire District and an area of Taranaki County adjoining thereto, is hereby constituted a united urban fire district by the name of the New Plymouth United Urban Fire District (hereinafter called "the said Fire District").

2. The number of members to be elected to represent the Councils of the City of New Plymouth and the County of Taranaki on the Board of the said Fire District shall be three who shall be elected in the following manner:

(a) Two members by resolution of the New Plymouth City Council.
