Revoking a Proclamation Declaring an Area in the Otago Acclimatisation District to be a Wildlife Refuge

ARTHUR PORRITT. Governor-General A PROCLAMATION

A PROCLAMATION PURSUANT to section 14 of the Wildlife Act 1953, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Internal Affairs and the Minister of Lands (being the Minister charged with the administration of the Department of State having the control of the land of the Crown affected by this Proclama-tion), hereby revoke the Proclamation issued on the 19th day of December 1957*, declaring an area of land in the Green-vale Survey District, in the Otago Acclimatisation District, to be a wildlife refuge for the purposes of the Wildlife Act 1953, as shown on plan marked I.A. 52/221 deposited in the Head Office, Department of Internal Affairs, Wellington, and thereon edged red.
