Plants Declared Noxious Weeds in the County of Westland (Notice No. Ag. 10278)

PURSUANT to section 3 of the Noxious Weeds Act 1950 and to a delegation from the Minister of Agriculture under section 9 of the Department of Agriculture Act 1953 for the purpose of the said section, the following special order, made by the Westland County Council on the 23rd day of May 1968, is hereby published.

Californian thistle (*Cirsium arvense*).

Fennel (*Foeniculum vulgare*).

Hemlock (*Conium maculatum*).

Ragwort (*Senecio jacobaea*).
