"That, for the purpose of providing the annual charges on a loan of \$400,000, to be known as No. 19 Reticulation Loan 1968, authorised to be raised by the Central Canterbury Electric Power Board under the above-mentioned Act for the purpose of further reticulating the Central Canterbury Electric Power District, the said Central Canterbury Electric Electric Power District, the said Central Canterbury Electric Power Board hereby makes a special rate of one-twenty-eighth (½8) of a cent in the dollar upon the rateable value (on the basis of the capital value) of all rateable property of the Central Canterbury Electric Power District, comprising the whole of the Counties of Ellesmere, Akaroa, Wairewa, Mount Herbert, Malvern, and Tawera, parts of the Counties of Paparua and Heathcote, and part of Lyttellton Borough; and that the special rate shall be an annually recurring rate during the currency of the loan, and be payable yearly on the list day of September in each and every year during the currency of the loan, being a period of 10 years, or until the loan is fully paid off".
