- (a) Not ordinarily resident in New Zealand (within the meaning of the Exchange Control Regulations 1965);
- (b) A trustee for or a nominee or agent of any person not ordinarily resident in New Zealand (within the meaning of the said regulations).
- 3. The non-resident accounts specified in the First, Second, Third, Fourth, and Fifth Schedules hereto are hereby declared to be controlled accounts for the purposes of regulation 48 of the Exchange Control Regulations 1965 (as inserted by regulation 4 of the Exchange Control Regulations 1965, Amendment No. 1).

 4. The Controlled (Non-Resident) Accounts Notice specified in the Sixth Schedule hereto is hereby revoked.
