1. This notice may be cited as the Traffic (Dunedin City) Notice 1968.

2. All the roads within the area specified in the First Schedule hereto, with the exception of those roads specified in the Second Schedule hereto, are hereby excluded from the limitation as to speed imposed by section 52 of the Transport Act 1962.

3. The roads specified in the Third Schedule hereto are hereby declared to be limited speed zones for the purposes of regulation 27 of the Traffic Regulations 1956\*.
