5. The trustees may enclose any part or parts of the foreshore described in the Second Schedule to this order for the purpose of holding athletic sports or games and may, by bylaws, fix a charge for admission to such enclosed part or parts:

Provided that the total number of days on which such enclosures are made shall not exceed six in any one year.

6. Nothing herein contained shall authorise the trustees to remove or cause to be removed any stone, sand, shingle, or shells without the consent of the Minister being first obtained.

7. The said rights, powers, and privileges may be at any time resumed by the Governor-General, without payment or any compensation whatever, on giving to the trustees six calendar months' notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to the last-known address of the trustees in New Zealand.
