PURSUANT to the Control of Prices Act 1947, I, Clifford Ernest Beard, pursuant to a delegation from the Secretary of Industries and Com-merce, acting under a delegation from the Price Tribunal, hereby make the following price order:

This order may be cited as Price Order No. 2092 and shall be read together with and deemed part of Price Order No. 2083* (hereinafter referred to as the principal order).
This order shall come into force on the 9th day of November 1968.

This order shall come into force on the 9th day of November 1900.
The principal order is hereby amended by revoking the Schedule thereto, and substituting the following Schedule.
