*The Traffic (Wellington Urban Motorway) Notice No. 2, 1968*

**NOTICE**

1. This notice may be cited as the Traffic (Wellington Urban Motorway) Notice No. 2, 1968.

2. The roads specified in the Schedule hereto are hereby declared to be 40-miles-an-hour speed limit areas for the purposes of regulation 27A of the Traffic Regulations 1956\*.

3. The Traffic (Wellington Urban Motorway) Notice 1968, dated the 26th day of April 1968†, which relates to Wellington Urban Motorway in Wellington City, is hereby revoked.

The off-ramp roadway (from the Wellington Urban Motorway to Aotea Quay).

The on-ramp roadway (from Aotea Quay to the Wellington Urban Motorway).
