## RESOLUTION MAKING AND LEVYING SPECIAL RATE

## Vehicle Testing Station Loan 1968, \$40,000

PURSUANT to the Local Authorities Loans Act 1956, the Rotorua County Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of \$40,000 authorised to be raised by the Rotorua County Council under the above-mentioned Act for the purpose of meeting part of the cost of purchasing land and erecting a vehicle testing station thereon, the said Rotorua County Council hereby makes a special rate of 0.0157c in the dollar upon the unimproved rateable value of all rateable property in the whole of the County of Rotorua; and that the special rate shall be an annual-recurring rate during the currency
