

*Allocating Railway Land for Street in the Borough of
Port Chalmers*

A PROCLAMATION

PURSUANT to section 226 of the Public Works Act 1928, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto (and which was taken for the South Island Main Trunk Railway and is not now required for such purpose) shall, upon the publication hereof in the *Gazette*, become street; and that such street shall be under the control of the Port Chalmers Borough Council, and shall be maintained by the said Port Chalmers Borough Council in like manner as other public streets are controlled and maintained by the said Council.

PURSUANT to the Local Government Commission Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order shall come into force on 1 April 1969.

2. The area described in the Schedule hereto shall be excluded from the County of Rangiora and included in the Borough of Rangiora.

3. The alteration of the boundaries of the said county and the said borough, hereinbefore made, shall be deemed to have been effected under the Municipal Corporations Act 1954.
