A PROCLAMATION

PURSUANT to section 2 (2) of the Maori Housing Amendment Act 1938, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby revoke the Proclamation, dated 11 April 1967, and published in *Gazette*, 20 April 1967, No. 25, p. 701, setting apart the land described in the Schedule hereto, for the purposes of the Maori Housing Act 1935.
