A PROCLAMATION

PURSUANT to the Public Works Act 1928 and section 15 of the Broadcasting Corporation Act 1961, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare, *first*, that the land described in the First Schedule hereto is hereby taken for a television broadcasting station and shall vest in the New Zealand Broadcasting Corporation from and after the date hereinafter mentioned; and, *secondly*, that an easement (right of way) is hereby taken for a television broadcasting station from and after the 10th day of March 1969 over the land described in the First Schedule hereto, vesting in the New Zealand Broadcasting Corporation the full and free right, liberty, and licence in perpetuity to lay, construct, reconstruct, inspect, repair, renew, and maintain a roadway along and across the land described in the Second Schedule hereto, together with the full and free right, liberty, and licence for the New Zealand Broadcasting Corporation, its employees, contractors, workmen, tradesmen, servants, agents, visitors, and licensees, at all times, by day or night, to pass and repass, with or without vehicles, along, over, upon, and through the land described in the Second Schedule, such easement to be forever appurtenant to the land described in the First Schedule hereto.
