ALL that area of the waters of the Waikouaiti River and Pacific Ocean having as its seawards limit the arc of a circle commencing on the landward boundary of the foreshore of the coast northwards of the said river; thence into the Pacific Ocean; thence to the landward boundary of the foreshore of the coast southwards of the said river, such arc being the arc of a circle of 1 nautical mile radius having as its centre Triangulation Station G., Hawkesbury Survey District, and having as its inner limit the line of the seaward side of the State Highway No. 1 bridge across the Waikouaiti River.
