"That, for the purpose of providing the annual charges on a loan of \$93,000 authorised to be raised by the Mosgiel Borough Council under the above-mentioned Act for the purpose of completing the construction of the sports pavilion on Memorial completing the construction of the sports pavilion on Memorial Park, the said Mosgiel Borough Council hereby makes a special rate of decimal two five cents (.25c) in the dollar (\$) upon the rateable value of all rateable property (on the basis of the unimproved value) of the Borough of Mosgiel, comprising the whole of the Borough of Mosgiel; and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of April in each and every year during the currency of the loan, being a period of twenty-five (25) years, or until the loan is fully paid off."

The above resolution was duly passed at a meeting of the Mosgiel Borough Council held on the 3rd day of June 1969.
