Pursuant to the Public Works Act 1928, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare that an easement is hereby taken hereby proclaim and declare that an easement is hereby taken for drainage purposes over the land described in the Schedule hereto, vesting in the Chairman, Councillors, and Inhabitants of the County of Eyre from and after the 30th day of June 1969 the full and free right, liberty, licence, and authority in perpetuity to lay, construct, place, reconstruct, inspect, cleanse, repair, renew, and maintain a line of pipes or an open drain along, under, or over the said land, with the right for the servants, agents, workmen, licensees, and invitees of the Chairman Councillors and Inhabitants of the County of Eyre to man, Councillors, and Inhabitants of the County of Eyre to go, pass, and repass, with or without horses or other animals or vehicles, over the said land, and to use the said line of pipes or open drain for the unimpeded conveyance of water.
