Maori Land Development Notice

WHEREAS by virtue of the notice described in the First Schedule hereto the land described in the Second Schedule hereto is subject to the provisions of Part XXIV of the Maori Affairs Act 1953; and whereas by subsequent order of the Maori Land Court the appellation of the land has been changed; and whereas it is desired to release part of that land from the provisions of Part XXIV, aforesaid, and to retain the balance under the provisions of Part XXIV under the current appellation:

Now, therefore, pursuant to sections 330 and 332 of the Maori Affairs Act 1953, the Board of Maori Affairs, hereby gives notice as follows.

NOTICE

1. This notice may be cited as the Maori Land Development Notice Whangarei 1969, No. 12.

2. The notice described in the First Schedule hereto is hereby amended by omitting all reference to the land described in the Second Schedule hereto.

3. The land described in the Third Schedule hereto is hereby released from the provisions of Part XXIV of the Maori Affairs Act 1953.

4. The land described in the Fourth Schedule hereto is hereby declared to be subject to Part XXIV of the Maori Affairs Act 1953.
