*Declaring a Right of Way Easement Taken for the Purposes of an Institution Established under the Child Welfare Act 1925 in Block II, Waiopahu Survey District, Horowhenua County, and Previous Declaration Revoked*

PURSUANT to the Public Works Act 1928, the Minister of Works hereby revokes the declaration dated the 21st day of January 1969, published in *Gazette*, 13 February 1969, No. 8, p. 230, and registered as No. 783852, Wellington Land Registry, declaring a right of way easement taken for the purposes of an institution established under the Child Welfare Act 1925 in Block II, Waiopahu Survey District, Horowhenua County, and hereby declares that, a sufficient agreement to that effect having been entered into, an easement (right of way) is hereby taken over the land described in the First Schedule hereto for the purposes of an institution established under the Child Welfare Act 1925, vesting in Her Majesty the Queen the full and free right, liberty, licence, and authority in perpetuity to construct and use a right of way, with rights for Her Majesty's servants, agents, workmen, licensees, and invitees, from time to time and at all times hereafter, to go, pass, and repass, with or without vehicles (loaded or unloaded), plant, or machinery, over the land described in the First Schedule hereto, for the purpose of providing access to the land described in the Second Schedule hereto; such right of way to be held forever appurtenant to the land described in the Second Schedule hereto and such right of way being maintained, repaired, and kept in good order and condition by the owner for the time being of the land described in the First Schedule hereto.
