Plan 14113, Sheet 2; thence along a right line to a point in the middle of the public road forming the south-western boundary of Allotment S.W. 172, Hunua Parish, in line with the southern boundary of the said road reserve, and along the middle of the public road forming the south-western boundaries of Allotments S.W. 172 and S. 172, the southern and eastern boundaries of Allotment S.E. 172, and the generally south-eastern boundaries of Allotments M. 172 and N. 172 and the subdivisions of Allotments 173 and 174 to a point in Block XII, Wairoa Survey District, in line with the northern boundary of Allotment 112; thence along a right line to and along that northern boundary and the northern boundary of Allotment 112A, the aforesaid allotments all being of Hunua Parish, and along that last-mentioned boundary produced to and up the middle of the Wairoa River to a point in line with the northern boundary of Lot 2, D.P. 33851; thence along a right line to and along the northern and eastern boundaries of that Lot 2 and continuing along the generally western, southern, and eastern boundaries of Lot 13, D.P. 49440, and the eastern boundary of Allotment 85 in Block XIII, Wairoa Survey District, to and along the southern and eastern boundaries of Allotment 88 to a point in line with the southern boundary of Allotment 96; thence along a right line across Allotment 167 to and along the southern and south-eastern boundaries of the said Allotment 96, the southern boundaries of Allotments 95 and 94, the said allotments all being of Otatau Parish, to the north-western boundary of Wharekawa 4C 1; thence south-westerly along the aforesaid north-western boundary and along the north-western, western, and southern boundaries of Wharekawa 4A 2, the southern boundaries of Wharekawa 4C 1, aforesaid, and the southern boundary of Wharekawa 4C 2c, and continuing along the northern boundary of Wharekawa 5c and its production to the middle of the Puwhenua Stream and down the middle of that stream to the sea coast in Block II, Wharekawa Survey District; thence southerly along the coast of the Firth of Thames to the northernmost corner of Allotment 82, Koheroa Parish, in Block VI, Wharekawa Survey District; thence generally westerly along the northern and western boundaries of that allotment, crossing and recrossing the Miranda-New Brighton Coast Road, to its junction with the middle line of the public road shown on S.O. Plan 6111; thence along the middle of that public road and continuing along the middle of Miranda Boundary Road and the production of the middle line of that part of Miranda Boundary Road forming the northern boundary of Lot 6, D.P. 33494, to and along the eastern, southern, and western boundaries of Allotment 213 to and along the middle of a public road, to and along the middle of a strip of land being those parts of Wharekawa 1 between Lot 15, D.P. 31704, and Lots 3 and 1, D.P. 27867, and Lot 13, D.P. 31704, to and along the middle of a public road which intersects Lots 23, 22, and 21, D.P. 7211, and forms the northern boundaries of Lots 4 and 3, D.P. 33468, and Allotments 157 and 158, all the aforesaid allotments being of Koheroa Parish, and along the middle of the Pokeno-Miranda Road to and along the middle of Section 2, Block XVI, Opaheke Survey District, to and again along the middle of another part of the Pokeno-Miranda Road to the middle of the Mangatangi Stream; thence generally south-westerly down the middle of that stream, the middle of Maramarua River, and the middle of the Whangamarino River to its intersection with a right line between the south-western corner of Allotment 17, Koheroa Parish, and a point on the left bank of the Waikato River in line with the south-eastern boundary of Allotment 93, Onewhero Parish; thence westerly along that right line to and along the aforesaid left bank of the Waikato River, part of which is the north-eastern boundary of Allotment 38, Koheroa Parish (Tuoro Island), to the sea coast; thence generally northerly along the sea coast to the point of commencement, excluding therefrom the Boroughs of Tuakau and Waiuku, as described in *Gazette*, 1956, p. 591, and the Borough of Pukekohe, as described in *Gazette*, 1958, p. 1473.

BOUNDARIES OF DRURY RIDING OF COUNTY OF FRANKLIN

ALL that area in the North Auckland Land District, Franklin County, bounded by a line commencing at a point on the Papakura Borough boundary in Block III, Drury Survey District, being the junction of the eastern side of the Auckland-Hamilton Motorway with the line of mean high-water, spring tide, of the Pahurehure Inlet, Manukau Harbour, and proceeding generally southerly and then easterly along that borough

boundary, as hereinbefore described, to that westernmost corner of the part Allotment 52, Opaheke Parish, comprised in C.T. 54/299, in Block IV, Drury Survey District; thence continuing along the south-western boundary of that part Allotment 52 to and along the south-western boundary of an area of 3.9 perches shown on S.O. Plan 44280, and along the production of that boundary for a distance of 87 links; thence along a right line bearing 227° 45' to and along the generally south-western boundary of the land shown on D.P. 3521 to the north-western corner of Lot 1, D.P. 55769; thence generally southerly along the western boundary of that Lot 1 and continuing along the western boundaries of Allotments 81 and 84, Hunua Parish, to the northern side of Ponga Road; thence southerly along a right line across that road to the northernmost corner of Lot 2, D.P. 28612, and along the western boundary of that lot, along a right line across a public road to and along the western boundaries of Lot 1, D.P. 28612, Lot 3, D.P. 55373, and continuing along the western boundary of Allotment 84 and the generally western boundaries of Allotments 86, 85, 185, 194, 197, and 199, to the westernmost corner of the last-mentioned allotment; thence easterly generally along the southern boundaries of that allotment and of Allotments 37 and 191, along the southern end of a public road, and along the southern boundaries of Allotments 202, 209, 243, 247, E. 210, 211, W. 212, and N.E. 212, all the aforesaid allotments being of Hunua Parish, to the left bank of the Mangawheau Stream; thence generally north-easterly along that bank to a point in Block VI, Opaheke Survey District, in line with the middle of a public road forming the south-western boundary of Lot 1, D.P. 29575; thence south-easterly generally along a right line across that stream to and along the middle of that road and its production to and along the middle of Allotment 306, Opaheke Parish, to and along the middle of a public road which forms the eastern boundary of Lot 3, Deeds Plan 49, and the north-eastern boundaries of Allotments 97, 201, and 202, to and along the middle of the public road which intersects Allotment 202 and forms the generally eastern boundaries of Allotments 207, 208, and Lot 3, D.P. 35940, to a point in Block X, Opaheke Survey District, in line with the northern boundary of Lot 3, D.P. 24929; thence easterly along a right line to and along that northern boundary and its production to the middle of a public road; thence southerly generally along the middle of that road which forms the western boundary of Allotment 133, the western and generally southern boundaries of Allotment 135, and the generally western boundary of Allotment 136, all the aforesaid allotments being of Opaheke Parish, to a point in line with the south-eastern boundary of Allotment 135, Mangatawhiri Parish, in Block XI, Opaheke Survey District; thence westerly generally along a right line to and along that boundary to the southernmost corner of that allotment and along a right line to the easternmost corner of Allotment 238, Mangatawhiri Parish; thence westerly generally along the southern and south-western boundaries of that allotment, and continuing along the northern and western boundaries of Lot 1, D.P. 40194, to and along the southern boundary of Allotment 235 and its production to the right bank of the Pouraureroa Stream; thence westerly generally along the generally southern boundary of Allotment 233 and its production to and north-westerly along the middle of the public road forming the generally northern boundary of Allotment 227 and along the middle of that road to a point in line with the western boundary of the said Allotment 227 in Block X, Opaheke Survey District; thence along a right line to and along that boundary to and along the southern boundary of Allotment 103 to Pinnacle Hill Road, and along the eastern side of that road to a point due east of the northernmost corner of Lot 1, D.P. 9244, in Block IX, Opaheke Survey District; thence along a right line across that road to and along the generally northern boundary of that lot to and along the eastern side of a public road which forms the western boundary of that Lot 1 to the southernmost corner of Allotment 169; thence along the production of the southern boundary of that allotment across the aforesaid public road to and along the eastern and northern boundaries of Allotment 168 to and along the north-eastern and north-western boundaries of Allotment 156 and along the last-mentioned boundary produced to the western side of the public road forming the eastern boundary of Allotment 147; thence along that roadside to and along the south-eastern side of the public road forming the north-western boundary of that allotment and continuing along that roadside to the westernmost corner of Allotment 146, the aforesaid allotments all being of Mangatawhiri Parish; thence along the eastern and southern boundaries of Allotment 20 of Suburban Section 2, Mangatawhiri Parish, and along the generally western boundary of Allotment 21 of Suburban Section 2 to and along the northern boundary of Allotment 37 of Suburban Section 2 and the north-western boundary of Allotment 11 of Suburban Section 2, aforesaid, and along the production of the last-mentioned boundary to the middle of the Old Great South Road; thence northerly generally along the middle of that road and continuing along the middle of the Great South Road to a
